

FELCO GIVEAWAY TERMS AND CONDITIONS

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. PRIZE ACCEPTANCE AGREEMENT IS REQUIRED. THIS SWEEPSTAKE IS OPEN ONLY TO NATURAL PERSONS WHO ARE LEGAL RESIDENTS OF AND PHYSICALLY LOCATED IN CANADA AND WHO HAVE REACHED THE LEGAL AGE OF MAJORITY IN THEIR JURISDICTION OF RESIDENCE AT THE TIME OF ENTRY. VOID WHERE PROHIBITED BY LAW. PARTICIPATION IN THIS SWEEPSTAKES CONSTITUTES ACCEPTANCE OF THESE OFFICIAL RULES. ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED. BY PARTICIPATING IN THE SWEEPSTAKES, EACH PARTICIPANT REPRESENTS AND WARRANTS THAT HE OR SHE MEETS THESE ELIGIBILITY REQUIREMENTS AND HAS READ, ACCEPTS AND WILL COMPLY WITH THESE OFFICIAL RULES.

1. SWEEPSTAKE PERIOD:

The *Felco Giveaway* (the “**Sweepstake**”) begins on March 13, 2025 at 12:00:01 a.m. Eastern Daylight Time (“**EDT**”) and ends on March 31, 2025 at 11:59:59 p.m. EDT (the “**Sweepstake Period**”).

2. ELIGIBILITY:

THIS SWEEPSTAKE IS OPEN ONLY TO NATURAL PERSONS WHO ARE LEGAL RESIDENTS OF CANADA AND WHO HAVE REACHED THE LEGAL AGE OF MAJORITY IN THEIR JURISDICTION OF RESIDENCE AT THE TIME OF ENTRY. Sweepstakes may only be entered from and within eligible jurisdictions. Employees and agents of Lee Valley Tools Ltd. (the “**Sponsor**”), its parent or subsidiaries and each of their respective affiliates (including, without limitation, Veritas Tools, Inc. and Lee Valley Tools USA Inc), , subsidiaries, successors, assigns and any entity involved in the development, production, implementation, administration, judging or fulfillment of the Sweepstakes (collectively, the “**Sweepstake Parties**”), and the immediate family members and/or those persons living in the same household of such individuals, are not eligible to participate or win a prize in this Sweepstakes. For the purpose of this Sweepstakes, immediate family is defined as spouse, partner, mother, father, legal guardian, in-laws, grandmother, grandfather, brother, sister, children and grandchildren.

3. HOW TO ENTER:

NO PURCHASE NECESSARY. You must fill out the form, then you will automatically be granted one (1) Entry (the “**Entry**”) in the Contest. You must follow the Lee Valley Tools Instagram Account (@leevalleytools) or Facebook Account (@leevalleytools) and tag someone in the comments who would enjoy this prize pack on the dedicated social media post, then you will automatically be granted one (1) Bonus Entry (the “**Bonus Entry**”).

4. ENTRY LIMIT:

There is a limit of two (2) Entries per person. If it is discovered by the Sponsor (using any evidence or other information made available to or otherwise discovered by the Sponsor) that any person has attempted to: (i) obtain more than two (2) Entries; and/or (ii) use multiple names, identities, email addresses, and/or any automated, macro, script, robotic or other system(s) or program(s) to enter or otherwise participate in or disrupt this Sweepstake; then he/she may be disqualified from the Sweepstake in the sole and absolute discretion of the Sponsor. The Released Parties (defined below) are not responsible for late, lost, misdirected, delayed, incomplete or incompatible Entries (all of which are void). No third-party entry or entry through a sweepstakes service is permitted.

5. RIGHT TO VERIFY:

All Entries are subject to verification at any time and for any reason. The Sponsor reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor – including, without limitation, government issued photo identification): (i) for the purposes of verifying an individual’s eligibility to participate in this Sweepstakes; (ii) for the purposes of verifying the eligibility and/or legitimacy of an Entry entered (or purportedly entered) for the purposes of this Sweepstakes; and/or (iii) for any other reason the Sponsor deems necessary, in its sole and

absolute discretion, for the purposes of administering this Sweepstake in accordance with these Official Rules. Failure to provide such proof to the complete satisfaction of the Sponsor in a timely manner may result in disqualification in the sole and absolute discretion of the Sponsor. The sole determinant of the time for the purposes of a valid Entry in this Sweepstakes will be the Sweepstakes server machine(s).

6. THE PRIZES:

At the end of the Sweepstakes Period, there will be one (1) Prize (a “**Prize**”) available to be won. The total approximate retail value (“**ARV**”) of the Prize in this Sweepstake is the value of the prize which is Four hundred seventy eight dollars (\$478.00) for the Felco prize pack.

The Prize must be accepted as awarded and is not transferable, assignable or convertible to cash (except as may be specifically permitted by Sponsor in its sole and absolute discretion). No substitutions except at Sponsor’s option. Sponsor reserves the right, in its sole discretion, to substitute any Prize with a prize of equal or greater value, including, without limitation, but at Sponsor’s sole discretion, a cash award. As part of the Prize acceptance agreement, the winner agrees to accept the Prize “as is”, and entrants hereby acknowledge that Sponsor has neither made nor are in any manner responsible or liable for any warranty, representation, or guarantee, express or implied, in fact or in law, relative to a Prize, including, without limitation, to a Prize’s quality, merchantability or fitness for a particular purpose or express warranties (if any) provided exclusively by a prize supplier that are sent along with a Prize. If winner does not accept or use the entire Prize (as awarded), the unaccepted or unused part of the Prize will be forfeited, and Sponsor will have no further obligation with respect to that Prize or portion of the Prize. Sponsor is not responsible for, and winner will not receive the difference between the actual value of the Prize at the time of award and the stated ARV in these Official Rules or any Sweepstakes-related materials.

7. WINNER SELECTION PROCESS:

One (1) eligible entrant will be randomly selected on the Draw Date, which will take place in Ottawa, ON, at approximately 4:00 p.m. ET, fourteen (14) business days after the end of the Sweepstakes Period. The random draw will include all eligible Entries submitted and received during the Sweepstakes Period in compliance with these Official Rules. The odds of winning depend on the total number of eligible Entries received during the Sweepstakes Period.

8. WINNER NOTIFICATION PROCESS:

The Sponsor or its designated representative will make a minimum of three (3) attempts to contact the selected entrant within five (5) business days of the applicable Draw Date. If the selected entrant cannot be reached within five (5) business days of the Draw Date, or if there is a return of any notification as undeliverable, the entrant may, at the Sponsor’s sole discretion, be disqualified. If disqualified, the entrant will forfeit all rights to the Prize, and the Sponsor reserves the right, time permitting and at its sole discretion, to randomly select an alternate eligible entrant from the remaining valid Entries received during the Sweepstakes Period, in accordance with these Official Rules

BEFORE BEING DECLARED A CONFIRMED WINNER, the selected entrant will be required to sign and return within ten (10) business days of notification the Sponsor’s affidavit of eligibility/liability release (declaration and release in Canada) form, which (among other things):

- (i) Confirms compliance with these Official Sweepstakes Rules (the “**Official Rules**”);
- (ii) Acknowledges acceptance of the Prize as awarded;

Except where prohibited by law or regulation, by participating, each entrant grants the Sponsor a perpetual, worldwide, royalty-free license to use his/her name, character, photograph, voice, biographical data and likeness in connection with the promotion of this Sweepstakes and Sponsor, in all forms of media and by all manners (now and hereafter known), in perpetuity, without entrant's consent, review or approval, and each entrant waives any and all claims and/or rights to receive any royalties or other compensation for the Sponsor's use thereof, unless prohibited by law.

All Entries become the property of the Sponsor. The Released Parties assume no responsibility for lost, delayed, incomplete, incompatible or misdirected Entries. This Sweepstakes is subject to all applicable federal, provincial and municipal laws. The decisions of the Sponsor with respect to all aspects of this Sweepstakes are final and binding on all entrants without right of appeal, including, without limitation, any decisions regarding the eligibility/disqualification of Entries and/or entrants.

In the event of a dispute regarding who submitted an Entry, Entries will be deemed to have been submitted by the authorized account holder of the account that follows, shares and tags the Lee Valley social media account. "Authorized account holder" is defined as the person who is assigned an email address by an internet provider, online service provider, or other organization (e.g. business, educational institute, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address. An entrant may be required to provide proof (in a form acceptable to the Sponsor – including, without limitation, government issued photo identification) that he/she is the authorized account holder of the email address associated with the Entry in question.

ANYONE DETERMINED TO BE IN VIOLATION OF THESE OFFICIAL RULES FOR ANY REASON IS SUBJECT TO DISQUALIFICATION IN THE SOLE AND ABSOLUTE DISCRETION OF THE SPONSOR AT ANY TIME.

The Sponsor, with the consent of the Régie, reserves the right to cancel, amend or suspend this Sweepstakes, or to amend these Official Rules, in any way without prior notice or obligation, in the event of any accident, printing, administrative, or other error of any kind, or for any other reason whatsoever. Without limiting the generality of the foregoing, the Sponsor reserves the right, in its sole and absolute discretion, to administer an alternate test of skill as it deems appropriate based on the circumstances and/or to comply with applicable law.

For Quebec residents: Any litigation respecting the conduct or organization of a publicity sweepstakes may be submitted to the Régie des alcools, des courses et des jeux for a ruling. Any litigation respecting the awarding of the prize may be submitted to the Régie only for the purpose of helping the parties reach a settlement.

The parties hereby consent to exclusive jurisdiction and venue of the courts located in Ontario in any action to enforce (or otherwise relating to) these Official Rules or relating to this Sweepstakes.
