# FELCO GIVEAWAY TERMS AND CONDITIONS

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. PRIZE ACCEPTANCE AGREEMENT IS REQUIRED. THIS SWEEPSTAKE IS OPEN ONLY TO NATURAL PERSONS WHO ARE LEGAL RESIDENTS OF AND PHYSICALLY LOCATED IN CANADA AND WHO HAVE REACHED THE LEGAL AGE OF MAJORITY IN THEIR JURISDICTION OF RESIDENCE AT THE TIME OF ENTRY. ### 1. SWEEPSTAKE PERIOD:

The Felco Giveaway (the "Sweepstake") begins on March 13, 2025 at 12:00:01 a.m. Eastern Daylight Time ("EDT") and ends on March 31, 2025 at 11:59:59 p.m. EDT (the "Sweepstake Period").

#### 2. ELIGIBILITY:

THIS SWEEPSTAKE IS OPEN ONLY TO NATURAL PERSONS WHO ARE LEGAL RESIDENTS OF CANADA AND WHO HAVE REACHED THE LEGAL AGE OF MAJORITY IN THEIR JURISDICTION OF RESIDENCE AT THE TIME OF ENTRY. Sweepstakes may only be entered from and within eligible jurisdictions. Employees and agents of Lee Valley Tools Ltd. You must follow the Lee Valley Tools Instagram Account (@leevalleytools) or Facebook Account (@leevalleytools) and tag someone in the comments who would enjoy this prize pack on the dedicated social media post, then you will automatically be granted one (1) Bonus Entry (the "Bonus Entry").

### 4. ENTRY LIMIT:

There is a limit of two (2) Entries per person. If it is discovered by the Sponsor (using any evidence or other information made available to or otherwise discovered by the Sponsor) that any person has attempted to: (i) obtain more than two (2) Entries; and/or (ii) use multiple names, identities, email addresses, and/or any automated, macro, script, robotic or other system(s) or program(s) to enter or otherwise participate in or disrupt this Sweepstake; then he/she may be disqualified from the Sweepstake in the sole and absolute discretion of the Sponsor. #### 7. WINNER SELECTION PROCESS:

One (1) eligible entrant will be randomly selected on the Draw Date, which will take place in Ottawa, ON, at approximately 4:00 p.m. ET, fourteen (14) business days after the end of the Sweepstakes Period. The random draw will include all eligible Entries submitted and received during the Sweepstakes Period in compliance with these Official Rules. The odds of winning depend on the total number of eligible Entries received during the Sweepstakes Period.

### 8. WINNER NOTIFICATION PROCESS:

The Sponsor or its designated representative will make a minimum of three (3) attempts to contact the selected entrant within five (5) business days of the applicable Draw Date. If the selected entrant cannot be reached within five (5) business days of the Draw Date, or if there is a return of any notification as undeliverable, the entrant may, at the Sponsor's sole discretion, be disqualified. If disqualified, the entrant will forfeit all rights to the Prize, and the Sponsor reserves the right, time permitting and at its sole discretion, to randomly select an alternate eligible entrant from the remaining valid Entries received during the Sweepstakes Period, in accordance with these Official Rules
