Day 1 / Thursday 5th November 2026

Antalya

Meals included: Dinner

Welcome to Türkiye! Your COP31 journey begins the Intrepid way. Upon arrival, you'll be met by our local representative at the airport and transferred to your hotel. Until 5:00 pm, feel free to rest after your journey or head out on your own to wander the streets of Antalya — perhaps getting pleasantly lost and starting your local food discoveries early. At 5:00 pm, meet your leader, co-hosts Dr Evan Center and Dr Susanne Etti and your fellow executives travelling on the trip for a short welcome briefing. Afterwards, we'll head out together for a welcome dinner, where you can get to know your fellow travellers while enjoying local flavours and soaking up the atmosphere of your first evening in Türkiye.

Day 2 / Friday 6th November 2026

Kaş

Meals included: Breakfast, Lunch

After breakfast, hop into your vehicle for the transfer to Kaş — a journey of approximately three hours. On arrival, enjoy a relaxed introduction to the town with your leader, taking in the effortless harmony of deep blues and lush greens that define this coastal setting.

Lunch will be hosted at Çi Neo Cucina, a restaurant known for its commitment to sustainable, biodiversity-positive gastronomy, including the use of invasive lionfish species as part of local marine conservation efforts.

Following lunch, take part in a facilitated 45-minute UNGCNA leadership workshop. This dedicated session provides in-depth learning time to unpack key COP31 dynamics, exchange insights with peers, and translate global climate developments into organisational action, grounded in a real, place-based context.

Later in the afternoon, continue to a locally women-run olive and lavender farm and take part in a hands-on olive harvesting experience. The owner will share insight into the olive-growing process, the operation's history, and the role the business plays within the local community and economy. After an introduction to the olive trees in the grove, you'll participate in harvesting before moving to a dedicated olive-curing workshop area set within the lavender garden.

The experience concludes with a guided tasting of olives and olive oil. The full activity lasts approximately 2–3 hours. We expect to arrive at our Kaş hotel by 5:30pm, with time to regroup before the end of the day.

Day 3 / Saturday 7th November 2026

Kas

Meals included: Breakfast, Lunch

After breakfast, transfer to Kekova for a full day on the water, enjoying a relaxed sailing experience along the crystal-clear coast of Kaş. Spend the day aboard a traditional gulet, swimming in turquoise waters or relaxing on deck while taking in the views and enjoying Sebahat's home-cooked local dishes and freshly brewed Turkish coffee. The experience offers a place-based insight into the role tourism can play in creating sustainable livelihoods and more equitable economic opportunity. The gulet is operated by local couple Sebahat and Mehmet, whose business has grown alongside Intrepid over more than 20 years. What began as a single boat has expanded into a multi-generational family enterprise, with their son now operating a second vessel — providing long-term income, employment and skills development across generations.

During the day, you'll also spend time with Sebahat, who was among the first women in southern Turkey to gain a boat licence and now encourages other local women to participate in tourism as a pathway to economic independence. Through a hands-on introduction to traditional oya embroidery and informal conversations on board, the experience illustrates how community-led tourism, supported by long-term partnerships with locally owned suppliers, helps keep economic benefit rooted in local communities while preserving cultural knowledge.

In the late afternoon, return to your hotel and reconvene for the second UNGCNA-facilitated leadership workshop. Building on the previous session, this workshop focuses on translating COP31 insights into concrete priorities for strategy, operations and leadership, with continued peer exchange and applied discussion.

Day 4 / Sunday 8th November 2026

Antalya

Meals included: Breakfast, Dinner

After breakfast, depart Kaş and transfer back to Antalya, a journey of approximately three hours. Upon arrival, continue to the Education and Research Centres to meet DEKAFOK, a local conservation organisation dedicated to supporting the sustainable use of our coastlines and protecting the species that call them home. DEKAFOK works to raise awareness and demonstrate how people and wildlife can coexist in harmony along our shores — particularly sea turtles, Mediterranean monk seals, and endangered dune plants such as sea lilies. Take part in an engaging talk held in an open-air classroom, featuring visual materials as well as real samples collected during fieldwork and displayed in the laboratory. The session will explore the life cycles of sea turtles, Mediterranean monk seals, and threatened dune ecosystems, while also highlighting DEKAFOK's conservation efforts and their collaboration with the tourism sector. Later, put this knowledge into action by joining a coastal clean-up, helping remove plastic and other human-made waste that threatens natural habitats and disrupts the balance of coastal ecosystems. Afterwards, return to your hotel and take some time to prepare for your farewell dinner. Tonight, we say goodbye the Turkish way. Come together one last time for a farewell dinner inspired by traditional meyhane culture, where local flavours, shared plates and good conversation provide the perfect way to wrap up this memorable journey.

Important Information

- Don't underestimate the weather at any time of year in Turkey. In the summer months, heat can be extreme. In winter months, some travellers have been surprised at how low the temperatures go. A hat, sunscreen, and clothing that can be layered will serve you well year-round.

No arrangements are being held at this point and the costing is subject to availability at time of booking. FAQs

Who is the Leadership Trip for?

This five-day Leadership Trip is designed for C-suite executives, board members and senior leaders seeking an immersive professional development experience to network with peers ahead of COP31.

UNGCNA participants, UN Global Compact participants and non-participants are welcome. Non-participants may wish to consider joining UNGCNA to obtain member pricing.

Eligibility criteria

- C-suite, board members or senior leadership
- Maximum two (2) staff per organisation

This trip is designed to complement engagement with COP31 (it does not include attendance at COP31 – see more on how to engage with COP31 below).

What travel advice should I check before booking?

We recommend checking your government's official travel advice for Turkey before booking and again prior to departure. This will provide the most up-to-date information on entry requirements, safety considerations and local conditions relevant to your trip.

This includes advice not only for your destination, but also for any countries you transit through as part of your flight route.

Where government advice recommends against travel to certain countries, travellers should ensure their flights are booked via alternative transit routes. It is your responsibility to confirm that your full itinerary, including all stopovers, complies with current travel advice and is covered by your travel insurance.

Do I need a visa for Turkey?

Travellers from some nationalities can travel to Turkey without a visa for up to 90 days within a 180-day period. Other travellers must apply for a visa online or through a Turkish embassy or consulate before travelling.

To enter Turkey, you may also need:

- A passport issued within the past ten years
- A passport valid for at least six months after return
- Proof of onward or exit travel [Learn more about visa requirements for Turkey](#)

Visa requirements vary by nationality, and obtaining the correct visa for your trip, including for any countries you transit through, is your responsibility.

We recommend checking your visa requirements as soon as you book your trip to allow sufficient time for document preparation and visa processing. You can confirm entry requirements for your nationality via your government's official travel advice, consular websites, or on our website here:

Do I need to purchase travel insurance before travelling?

Yes. Comprehensive travel insurance is essential for this trip.

Your policy should cover all regions included in your itinerary, including countries you transit through, and provide appropriate medical, evacuation and cancellation cover. We recommend confirming this with your insurer before booking.

All travellers are required to have travel insurance before the start of their trip. Your policy should cover all regions included in your itinerary, including any countries you transit through, and provide appropriate cover for medical expenses, emergency evacuation and repatriation, trip cancellation, and personal liability.

It's important to understand that each country you visit may have specific entry requirements, and some destinations require proof of travel health insurance for all foreign travellers, regardless of nationality.

At a minimum, your policy must cover medical expenses and emergency repatriation. Coverage requirements may vary between trips, so please check the Travel Insurance section of your Essential Trip Information carefully. You will not be permitted to join the group until your trip leader has sighted:

- Your insurance policy number, and
- Your insurer's 24-hour emergency contact number

These details will be recorded on the first day of your trip.

Can you help me book flights?

Yes, our team can book flights for you.

Can I extend my accommodation booking before or after the Leadership Trip?

Yes, subject to availability.

All prices shown for additional services are indicative only and provided on an on-request basis. Final pricing and availability are subject to confirmation at the time of booking.

Accommodation can book out quickly around major international events such as COP31. If you're considering extending your stay, we recommend getting in touch with our team as early as possible to discuss your options

How do I secure my spot on the Leadership Trip?

To secure your place, a \$400 AUD deposit is required at the time of booking. Your booking will be confirmed once the deposit has been received.

The deposit forms part of your total trip cost, with the final balance due 90 days prior to departure.

When is the final balance due?

The final balance payment is required 90 days prior to travel.

What if I need to cancel my booking?

Cancellation by the traveller

The following cancellation fees apply:

- More than 90 days prior to departure: loss of deposit
- 89 days or fewer prior to departure: 100% cancellation fees apply

- No-shows: treated as a cancellation and incur 100% cancellation fees

What happens if Intrepid cancels the trip?

Cancellation by Intrepid is handled in line with Intrepid's standard booking conditions, as detailed in Clause 8 of the Standard Booking Conditions.

How do I get into COP31?

The UNFCCC's COP conference is typically divided up into two points of access via the Green Zone and the Blue Zone. The Green Zone is open to the public and the Blue Zone – which houses the Global Climate Negotiations – requires delegate approval, which can be applied for via the Australian Government's [COP31 Engagement Hub](#).

What is the timeline for approvals for COP31?

All announcements about applications and approvals come through the [COP31 Engagement Hub](#). In previous years, the application process for Blue Zone access was announced around July/August, with approvals starting around September/October.

Does attendance at the Leadership Trip guarantee Blue Zone access?

No, it does not. All attendees will have to apply through the COP31 Engagement Hub. While the UNGCNA cannot offer direct Blue Zone delegate passes, the UNGCNA team are available to talk through the application process and offer general insights and support.

How do I stay informed on COP31 updates?

We recommend you sign up for updates the Australian Government's [COP31 Engagement Hub](#).

Can participants bring a partner along?

This trip is designed as a small group learning experience, with participant numbers intentionally kept limited to support meaningful discussion, connection and immersion. For this reason, partners are not included on the trip.

How to Book

If you are happy with the quotation and itinerary please advise your names as per passport and your dates of birth for all travellers. Once we have this information we can send you an invoice. Once the tour has been confirmed final payment will be due no later than 90 days prior to travel. We can only hold arrangements for a group once we have received deposit.
