

EverBank Applicant Privacy Notice

EverBank, N.A. and its affiliates and subsidiaries (collectively, "EverBank" or "EverBank Companies") collect personal information on individuals who apply for or are recruited for employment with EverBank. We collectively refer to all of these in this Privacy Notice as "Applicants." This Applicant Privacy Notice describes what personal information we may collect, how we may use that personal information, and to whom we may disclose it.

This Applicant Privacy Notice does not cover:

- Your interactions with EverBank outside of the employment application or recruiting context, such as browsing
 our customer website or opening or maintaining a deposit account. To learn more about how we collect and use
 information related to those types of interactions, please see our Notice of Online Privacy Practices at
 everbank.com/legal/privacy with other linked privacy notices.
- Active and Former Employees. To learn more about how we collect and use information while you were or are employed with us, please see our <u>Associate Privacy Notice</u>.

Categories of Applicant Personal Information we may collect or generate

Personal information

The kinds of personal information we collect or generate about you may include:

- Name, identity and contact details such as your name, address, email address, telephone, other contact information and personal preferences
- Government-issued identifiers such as a Social Security or driver's license number
- Demographic information and personal characteristics such as age, race, ethnicity, sexual orientation, marital status, medical conditions, and military or veteran status
- Employment details such as details of your employment and professional background, including position, work experience, employment references, past salary/desired salary, and other compensation requests
- Background information such as your educational background including degrees, certificates, transcripts, credit history and/or criminal background screenings (where relevant to your application and permitted under applicable law)
- Biometric information such as fingerprints and faceprints, depending on your job function
- COVID-19 and similar data subject to applicable laws and during the COVID-19 public health pandemic or other
 designated health emergency, for workplace health and safety purposes, your COVID-19 or similar vaccine
 immunization status, and/or negative COVID-19 or similar screening tests (including date and time), prior to
 accessing any physical location that is owned, leased, or operated by EverBank and used to conduct EverBank
 business activity ("EverBank Premises"). For more information, please refer to EverBank's Notice of Online Privacy

- Internet, Network Access, Online and Technical Information such as certain technical information from you
 or the devices you use related to your visit to our website using Internet Protocol (IP) address, device ID on our
 smartphone or tracking technologies such as web beacons, pixels and cookies. For more information about
 our use of cookies and similar technologies, please refer to EverBank's Notice of Online Privacy Practices on our
 website at.everbank.com/legal/privacy.
- Sensory and Surveillance Information such as, audio and visual recordings.
- Any other information in your application or other workplace interactions that you choose to share with us such as personal preferences, hobbies, and social preferences
- Inferences and Profiles inferences or insights we may draw from any of the above information, as permitted by applicable law, such as those drawn to reflect your preferences, characteristics, psychological trends, predispositions, intelligence, abilities, and aptitudes

We do not hire minors under sixteen years of age and therefore do not collect Applicant Personal Information from them.

Sensitive personal information

EverBank may collect certain Applicant Personal Information considered "sensitive" ("Sensitive Personal Information"). Sensitive personal information may be included in some of the categories we described above. For example, as stated above, during the COVID-19 pandemic or similar health emergencies, EverBank may be subject to applicable laws, collect health information related to COVID-19 or similar vaccination status, test results and related screenings prior to the applicant or accessing EverBank Premises. Also, if you have a disability and would like for us to consider an accommodation, you may provide that information during the recruitment process.

For some countries, EverBank may ask for information such as race, ethnicity, gender or gender identity, or sexual orientation for the purposes of monitoring equal opportunity; however, for the purposes of your application we do not require applicants to provide this information. If you provide this information, it will not be considered in the hiring or selection process. To the extent that you provide us with sensitive personal information (race, ethnicity, political opinions or beliefs, membership of a trade union or political party, physical or mental health information, precise geolocation, sexual orientation or information related to criminal convictions or offences), you expressly authorize EverBank to handle such information in accordance with this Privacy Notice.

Information from third parties

From time to time, we may obtain information about you from public sources or third parties, such as data aggregators or companies with which we have business relationships. For example, we may conduct background screenings through a third-party service provider and verify information that you have in your application that relates to your past education, employment, credit and/or criminal history, as allowed by applicable law. You may also choose to provide us with access to certain personal information stored by third parties such as job-related social media sites (for example, LinkedIn). By applying, you authorize EverBank to have access to this information and agree that EverBank may collect, store, and use this information in accordance with this Privacy Notice.

How EverBank uses your personal information

We only use Applicant Personal Information for our business purposes. We will use your personal information for:

Conducting and completing the application process for which the Applicant Personal Information was collected
and taking other actions reasonably anticipated within the context of your employment application, such as

identifying, authenticating, and keeping in contact with you.

- Preventing, detecting, and investigating security incidents, protecting against malicious, deceptive, fraudulent, or illegal activity, or prosecuting those responsible for such activities.
- Ensuring that our websites continue to operate as necessary, and to permit you to access the online portals that you need to apply for employment with us.
- Complying with a legal obligation, including our records retention obligations, employment laws and regulations, to answer subpoenas or requests from regulators.
- Enhance our candidate process.
- Making other internal and lawful uses of that information that are compatible with the context in which you
 provided it and for our business purposes.

If an Applicant becomes an EverBank associate or contractor, Applicant Personal Information becomes part of your employment file and is used in accordance with our EverBank Associate Privacy Notice.

With whom will EverBank share your personal information?

We take care to share your personal information only with those who really need it to perform their tasks and duties, and to third parties with a legitimate business need. We may disclose your personal information to the following types of third parties for the business purposes described in this Privacy Notice:

Affiliates, subsidiaries, and other EverBank Companies

Your personal information may be shared for the purposes described above with other EverBank Companies. To the extent a list of other companies within EverBank is not available on our main website, it may be requested through one of the contacts below.

Third party service providers and professional advisors

We may also share your personal information with third parties who provide services to us such as recruitment agencies, consultants, background services, auditors, and attorneys. If your personal information is shared in this way, EverBank do so only on a "need-to-know" basis and we will seek to ensure it is only used in connection with the functions or services these parties will be performing for EverBank and that your personal information is treated by them in a confidential manner. These service providers that EverBank uses may change depending on the EverBank entity that employs you and may change over time but we will always seek to ensure that any third parties who handle your personal information will do so in a manner consistent with this Privacy Notice and in accordance with applicable law.

EverBank does not sell your Applicant Personal Information to third parties. EverBank will notify you of an intended change in our use of Applicant Personal Information in this regard and obtain your prior consent before implementing it.

Governmental authorities, business transfer parties, and other third parties

EverBank may also disclose your personal information to other third parties including: - As necessary to comply with our legal obligations, including in order to respond to a lawful government request, court order, administrative or judicial process (such as a subpoena or search warrant) - As necessary to establish, exercise or defend our legal rights - As necessary to protect your vital interests (for example, we may need to share your personal information with third parties in the event of an emergency) - Where we have otherwise obtained your consent

How long do we keep your personal information?

We will keep your personal information for as long as necessary in connection with the purposes described in this Applicant Privacy Notice and in accordance with EverBank's retention policy and applicable law. California Applicant Privacy Notice and Notice at Collection

This EverBank California Applicant Privacy Notice and Notice at Collection (this "Notice") is for Applicants for EverBank positions ("Applicant(s)") residing in California and is made available pursuant to the California Consumer Privacy Act and its implementing regulations, as subsequently amended by the California Privacy Rights Act (collectively, the "CCPA"). EverBank, in this Notice, refers to EverBank, N.A., and its subsidiaries and affiliates (collectively, "EverBank" or the "EverBank Companies"). Capitalized terms used but not defined in this Notice shall have the meanings set forth in the CCPA.

If you are applying for a job with EverBank and you reside in California, please review this Notice carefully, as it applies to the personal information we collect about you solely in your capacity as an Applicant. We encourage you to read this Notice as well as the EverBank Notice of Online Privacy Practices at everbank.com/legal/privacy to have a more complete description of our online and offline data practices.

If you receive an employment offer for EverBank, you may receive additional requests for information, including a background check, subject to additional disclosures.

Under the CCPA, personal information includes information that identifies and describes who you are; as well as information that relates to, is capable of being associated with, or could reasonably be linked to you, one of your devices and/or a member of your household. In this Notice, we refer to the information subject to the CCPA as "Applicant Personal Information."

Our business purposes

Certain activities we perform require the use of your Applicant Personal Information and/or your sensitive Applicant Personal Information. Under the CCPA, you may not request that we (i) delete it; (ii) limit our use of your Applicant Personal Information or sensitive Applicant Personal Information; or (iii) limit our sharing it with our service providers when our activities fall within our "business purposes".

Online & Technical Information

We collect this type of information from:

- You and from your connected devices when you interact with our websites and mobile applications. For example, when you visit our websites, our server logs record your IP address and other information.
- Through digital tracking technologies such as cookies, pixels, and beacons

We also associate information with you using unique identifiers collected from your devices or browsers.

- To measure the level of engagement with the EverBank employment application websites
- To deliver content to you as an Applicant
- For our business purposes

(e.g., not applicable to sensitive personal information), to create a profile or summary about the individual
reflectingtheir preferences, abilities, aptitudes, psychological trends, behavior, predispositions, and characteristics

Purpose for collecting and disclosing the Employee Personal Information:

We use this type of information:

- To assist in assessing aptitude and ability for positions for which you have applied
- For security and risk management, fraud prevention and similar purposes
- For our business purposes

We may disclose this type of information to:

- EverBank Companies
- Our service providers that process information on our behalf
- Benefits providers
- Professional advisors
- Any successor to all or part of our business

- Complete access account credentials (such as account numbers or card numbers combined with required access/security code or password)

- Racial or ethnic origin
- Religious or philosophical beliefs
- Personal information concerning health, sex life, or sexual orientation

Purpose for collecting and disclosing the Employee Personal Information:

We may use this type of information:

- We process such information only for those purposes expressly permitted under the CCPA

Categories of third parties to whom this type of Employee Personal Information is disclosed for a business purpose:

We may disclose this type of information to:

Categories of third parties with whom this type of Employee Personal Information is sold or shared:

We do not sell this information for money or share this personal information with third parties for cross-context behavioral advertising or other activities from which you are entitled to opt-out.

Your rights under the CCPA

If you are a California resident, you have the following rights with respect to your Applicant Personal Information:

- Receive information on our privacy and information practices, including why we collect Applicant Personal Information about you, from whom, for what purposes, and with whom we share or "sell" it. This information is contained in the chart above. You are also entitled to know how long we expect to retain your Applicant Personal Information. Our retention period for Applicant Personal Information is generally five years from the date of creation, and may be extended under some circumstances, such as anticipated or ongoing litigation or regulatory activities.
- Request access to Applicant Personal Information that we have collected about you in the twelve months
 prior to your request. Please note that we are not required to disclose any Applicant Personal Information that
 may compromise the security of your information or put you at risk of identity theft; for example, we will not
 disclose to you your specific Social Security number if we have collected it.
- Request the deletion of your Applicant Personal Information, if we use it outside our business purposes (which are explained above).
- Request the correction of your Applicant Personal Information.
- Limit the use of your sensitive Applicant Personal Information, if we use it outside our business purposes. We may collect sensitive Applicant Personal Information if you voluntarily provide it to us for self-identification purposes. If we extend an offer to you for employment, we will also collect your age, date of birth, government issued identification numbers (such as Social Security or Driver's License); we use this information solely to comply

with employment laws and regulatory requirements. These use cases are considered to be "business purposes" under CCPA. Therefore, the right to limit our use of your Sensitive Applicant Personal Information is not available at this time.

- Opt-out of certain automated decision-making. Until the California regulators define automated decision
 making, we are not yet able to offer this right to you. We do not use automated decision-making in a way that will
 materially impact your legal rights or discriminate against you.
- Receive information whether we "sell or share" your Applicant Personal Information with vendors that provide
 cross-context digital advertising or cannot assure us that your Applicant Personal Information is used only to
 deliver services we have hired them to provide us. You are also entitled to opt-out of any such "sale or sharing."
 We do not sell or share with anyone any of your Applicant Personal Information.
- Not be discriminated against for exercising these rights.

What to Expect When You Exercise an Available CCPA Right

Verification and response process

We take protecting your Applicant Personal Information very seriously. When you make a request, we will first take steps to verify that it is really you who is making the request. Depending on the sensitivity of your Applicant Personal Information, we may request that you provide us with additional documentation to verify your identity and may decline your request if we are unable to verify your identity. To provide a "verifiable request" you must provide enough information that allows us to reasonably confirm and verify you are the person about whom EverBank collected Applicant Personal Information or you are the attorney-in-fact of a California resident.

Access to Applicant Personal Information

Once we have verified your request, we will provide information from our records for the preceding 12 months, including the business purpose for our collection. We will also direct our service providers to do the same if they are holding your Applicant Personal Information. Please note, we may decline your request if we are unable to verify your identity. We also decline to provide you with any of your Applicant Personal Information that may put you at risk of ID theft or create a security risk. For example, we would not disclose to you a specific government-issued ID number.

Deletion of Applicant Personal Information
