

Alle-Catt Wind Farm Construction Notice July 2024

Beginning on or about July 1, 2024, with continued work through April of 2025, Alle-Catt Wind Energy LLC (ACWE) will commence construction of the Alle-Catt Wind Farm Operations and Maintenance (O&M) building and related site improvements located at the intersection of Route 98 and B&S Road in Freedom, New York (Parcel ID 23.002-2-6). In addition, ACWE will install four stabilized construction entrances starting in September of 2024, located at 11439 Brown Schoolhouse Road (Parcel ID 13.002-1-8.1) and 10220 Sandbank Road (Parcel ID 23.001-1-18) in Freedom, and 9632 County Road 3 (Parcel ID 12.-1-19.4) and 10341 Rushford Rd (Parcel ID 37.-1-14.6) in Centerville, New York. These construction activities will support the development of a 340-megawatt (MW) wind-powered electric generation facility located in the Towns of Arcade, Centerville, Rushford, Farmersville, and Freedom, in Allegany, Cattaraugus, and Wyoming Counties, New York (Facility).

This notice is being provided in accordance with Certificate Condition 21 of the Certificate of Environmental Compatibility and Public Need (Certificate) issued by the New York State Board on Electric Generation Siting and the Environment (Siting Board) on June 3, 2020. A copy of the Certificate (and all public documents filed in this proceeding), including the approved O&M Building and Stabilized Construction Entrance Compliance Filing Package, may be accessed electronically at the Department of Public Service (DPS) website, www.dps.ny.gov. BRIEF DESCRIPTION OF THE PROJECT

When completed, the Project will consist of up to 83 wind turbines with a maximum generating capability of approximately 340 MW. The Project will also consist of associated improvements, including buried electrical cables, pad-mount transformers, access roads, an electrical substation, permanent meteorological towers, microwave tower, IdentiFlight towers, aircraft detection lighting systems (ADLS), and the O&M building. All Facility components will be located within an area encompassing approximately 20,131 acres (the Facility Site).

THE CONSTRUCTION SCHEDULE

The construction activities that are the subject of this notice are scheduled to begin on or about July 1, 2024. Construction activity will be limited to the hours between 7 a.m. and 7 p.m., or daylight hours outside this window, Monday through Saturday.

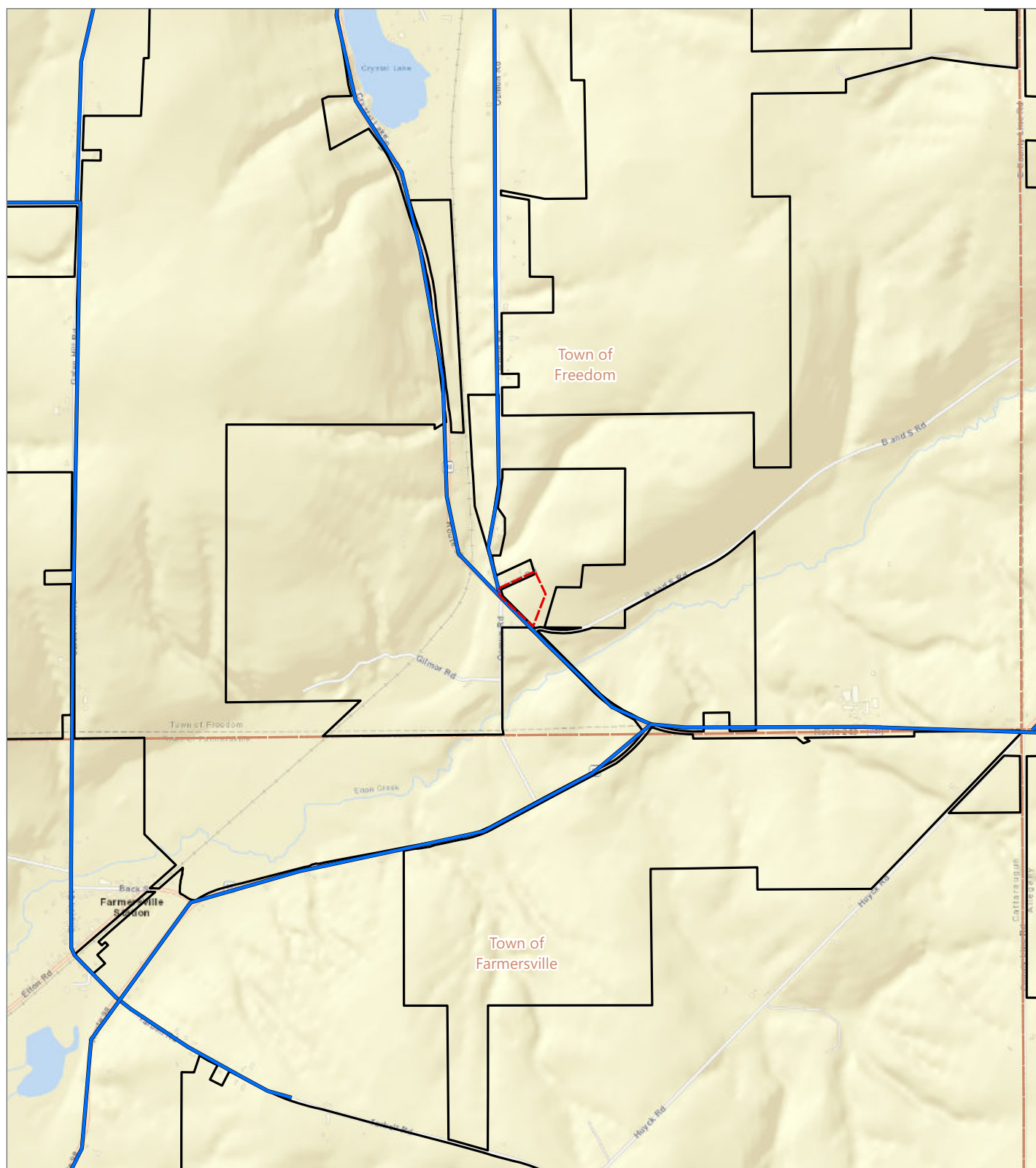

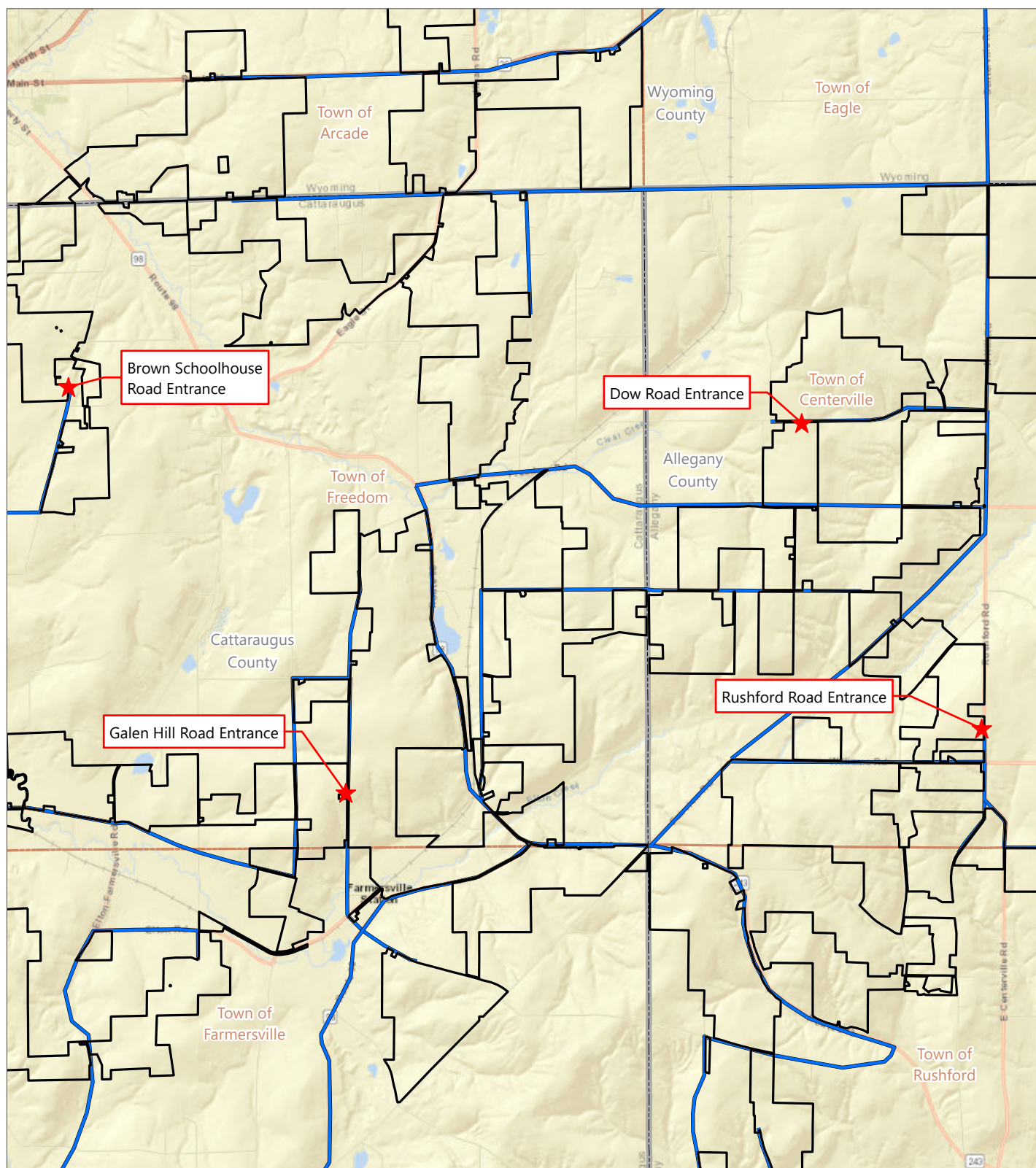
