The essential terms of a standard wind lease grant the wind company the right to install wind turbines, cables, roads, and other facilities on the property and the right to operate such facilities for a period of 20 years or more. In exchange the landowner is paid an annual fee based on the number of turbines installed on the property.
2. Compensation depends on number of turbines on the property, revenues received from turbine operation, which in turn vary with wind and energy prices.
3. Unless noted otherwise, all agreements are in place as of the date of this table.
4. The essential terms of a standard transmission easement grant the wind company the right to install electrical transmission facilities on the property and the right to operate such facilities for a period of 20 years or more. In exchange, the landowner is paid an annual fee based on the number of acres associated with the easement.
5. Terms of municipal officers are the best information readily available. Dates that are not verified as correct are shown in brackets.
