Sample Bequest Language

Bequest Gifts through Will/Trust: If your client is interested in supporting Corewell Health West Michigan or Helen DeVos Children's Hospital through a bequest in their will/trust, we have created the following sample bequest language as a helpful resource.

Residual Bequest Language. A residual bequest comes to the Corewell Health Foundation West Michigan after estate expenses and specific bequests are paid:

We give and devise to Corewell Health Foundation West Michigan (Tax ID #38-2752328), located in Grand Rapids, MI, all (or state a percentage) of the rest, residue, and remainder of our estate, both real and personal, to be used for its general support (or for the support of a specific fund or program).

Specific Bequest Language. Naming the Corewell Health Foundation West Michigan as a beneficiary of a specific amount from the estate:

We give and devise to Corewell Health Foundation West Michigan (Tax ID #38-2752328), located in Grand Rapids, MI, the sum of \$_____ (or asset) to be used for its general support (or for the support of a specific fund or program).

Contingent Bequest Language. Corewell Health Foundation West Michigan can be named as a contingent beneficiary in a will or personal trust if one or more specific bequests cannot be fulfilled:

If (insert name) is not living at the time of our demise, we give and devise to Corewell Health Foundation West Michigan (Tax ID #38-2752328), located in Grand Rapids, MI, the sum of \$_____ (or all or a percentage of the residue of our estate) to be used for its general support (or for the support of a specific fund or program).

Alternative Purpose Language. Recognizing that health care evolves to meet the ever-changing needs of future generations, your client may wish to grant Corewell Health Foundation West Michigan or Helen DeVos Children's Hospital Foundation the authority to respond to those changing needs. They may do this by including the following language with their bequest:

If at any time in the judgment of Corewell Health Foundation West Michigan or Helen DeVos Children's Hospital Foundation, it is impossible or impracticable to

carry out the designated purpose, the Foundation shall determine an alternative purpose as near as possible to the designated purpose.
