Kurnell Energy and Industry Hub

Ampol understands there has been some confusion in the community about the MOD-7 planning application at Ampol's Kurnell site which may be causing some unnecessary concerns.

To clarify:

- MOD-7 relates to infrastructure relocation and remediation of legacy refinery land. It is being assessed under the State Significant Development (SSD) planning pathway, with oversight from relevant NSW regulatory agencies.
- Capping asbestos-contaminated soils is a safe, regulated, and an accepted remediation method. At Kurnell, this approach is supported by an independent, EPA-accredited site auditor.
- Capping is used in various settings, including residential areas, schools, and recreational fields.
- Capped areas will be subject to ongoing management under sitespecific Environmental Management Plans to ensure long-term safety.
- Materials identified as unsuitable will be removed and disposed of in accordance with regulations.
- The stormwater design proposed does not alter existing discharge flows. Risk assessments and modelling are conducted under regulatory oversight in line with regulatory requirements to ensure no offsite impacts, including to Towra Point Nature Reserve.

Vessel noise update

The investigation into recent community concerns about noise from vessels operating at the Ampol Wharf has now been completed. It was conducted collaboratively by Ampol's Marine Assurance team, vessel operators, and an independent noise specialist.

The findings identified the primary source of the noise as a key safety system onboard the vessels. This system plays a critical role in ensuring product can be safely discharged from the vessel.

As a result of the investigation and its findings, the vessels involved have been temporarily removed from Ampol's approved list of vessels permitted to berth at the wharf. This suspension will remain in place until the vessel operators can demonstrate effective enhancements to their noise mitigation measures.

The NSW EPA have been kept updated on our investigations.

Ampol remains committed to working closely with all vessels operating at the wharf, to ensure compliance with Ampol's stringent marine assurance standards.

TERMINAL SIREN

Our siren is tested everyday at 12noon with a 1 x 10 second blast, and 2 x 10 second blasts on Monday.

The siren is for on-site personnel only and people in the community do not need to take action.

In the unlikely event of a major incident, that has potential to impact the community, Ampol will provide initial alerts and information via its community notification platform.

Residents are advised to always follow and direction from emergency services.
