

FREQUENTLY ASKED QUESTIONS

What is the difference between the application and a License Agreement?

The application is for you to provide information about your business and its legal entity in order to prepare a license agreement. The license agreement is the actual contract that is legal and binding, and it will spell out the specific details regarding what a licensee can sell or promote on agreed upon terms. No licensee is allowed to set up inside the mall without an executed license agreement.

When is my signed License Agreement and money due?

You will need to return your signed license agreement via Docusign. All license agreements are executed via Docusign. The security deposit and one times such as administrative fee, sign fee, start-up fee are due upon final execution of the agreement. First month rent and fixed additional fees must be paid on or before the start date and on the first day of the month thereafter.

What is a certificate of insurance (COI)?

A certificate of insurance is a document that verifies an individual or business has insurance coverage. It is issued by an insurance company and summarizes the policy's key details and conditions. We require all tenants who occupy a physical location to provide a COI with additional insureds per mall requirements.

Do you require a business permit/license?

Tenants are required to obtain applicable state, city, and county licenses and permits associated with their business model.

What is the difference between a RMU (cart) and a kiosk?

A retail merchandising unit, aka cart, is mall provided, easily movable and licensed to the cart operator per the terms of their agreement. Many malls also provide fixtures that can be utilized. A kiosk is typically provided by the tenant and prior approval must be obtained before bringing it into a mall in designated areas.

FREQUENTLY ASKED QUESTIONS cont.

Why am I required to report sales and pay percent rent?

Reporting sales allows us to evaluate how your business is performing in a mall. A "Base Plus Percent Rent" structure allows us to reduce your exposure (risk) to make it easier for you to say 'yes' to bringing your business to the mall. You commit to a smaller monthly base rent, and only pay additional percentage rent if your sales exceed the predetermined 'breakpoint'.

How do I create a sign for my inline location?

Before you create or install a sign, it will need to meet our sign requirements and follow the criteria in the license agreement. Working with a local sign company can be cost-effective. Your local leasing and advertising manager will be able to assist you with recommendations.

How are you able to offer such affordable rates?

Our Local Leasing program is intended to supplement our permanent leasing tenant mix with local and national small businesses. We offer highly subsidized rates on our License Agreements to provide more affordable access. In exchange, we reserve the right to relocate our Licensees in the event that we need to recapture the space for another use. In the unfortunate event that we are unable to relocate the Licensee, we also reserve the right to end the agreement.
