2017-2020

Strategic planning

Priority is to promote industry development



2020-2022

Beginning of regulatory oversight

Non-binding national standards, focusing on technical aspects



2022 - present

Supervision on specific AI technologies

Recommendation algorithm



Key themes





#### Hong Kong

- No binding AI legislation; best-practice guidance
- The Office of the Privacy Commissioner for Personal Data (PCPD)
  - Guidance on the Ethical Development and Use of Artificial intelligence (August 2021)
  - Artificial Intelligence: Model Personal Data Protection Framework on AI (11 June 2024)
  - Checklist on Guidelines for the Use of Generative AI by Employees (March 2025)
- Sectoral guidance in financial sector
  - Hong Kong Monetary Authority (HKMA)
  - The Securities and Futures Commission (SFC)



#### Singapore

- No comprehensive AI legislation; soft guidelines
- Updated AI Model Governance Framework for traditional AI and Gen-AI (May 2024)
  - 9 proposed dimensions to support and foster a trusted AI ecosystem
- Advisory Guidelines on use of Personal Data in AI Recommendation and Decision Systems (March 2024)
  - When to rely on exceptions under the PDPA when using personal data to develop AI systems
  - Recommended data handling and accountability measures when deploying AI systems
- Information Paper on Artificial Intelligence Model Risk Management (December 2024)



#### Indonesia

- Draft AI specific regulation on the horizon
- MOCI's Circular Letter on AI Ethical Guidelines (December 2023)
  - Ethical guidelines on the use of AI from a data protection perspective
- OJK's Guidelines for AI Use among Financial Institutions (April 2025)
  - Responsible development and implementation of AI technologies within the banking sector
  - Key requirements in relation to data governance and security



Korea: AI Basic Act, Asia's first comprehensive AI legislation

- Similar regulatory approach to the EU AI Act
- Risk-based, tiered obligations
  - High-impact AI systems vs. Gen-AI systems
- Minimum obligation to inform users of the use of AI and enhanced obligations to implement safety and reliability standards, risk management plans, human oversight and impact assessments
- Extra-territorial effect
- Penalties for non-compliance



## **AI** developers

#### Data privacy considerations

- Data minimisation principle
- Lawful bases for processing personal data in developing and training AI
  - Sensitive personal data
- Transparency and disclosure
- Performing data protection impact assessments
- Responding to data subject rights requests
- In-house AI tools



## AI deployers

#### Data privacy considerations

- Due diligence on AI model development and training
- Understanding the model's functionality and limitations
- Relying on lawful bases to process personal data using AI
- Performing data protection impact assessments
- Responding to data subject rights requests
- Acceptable AI use policies and AI literacy trainings for staff
