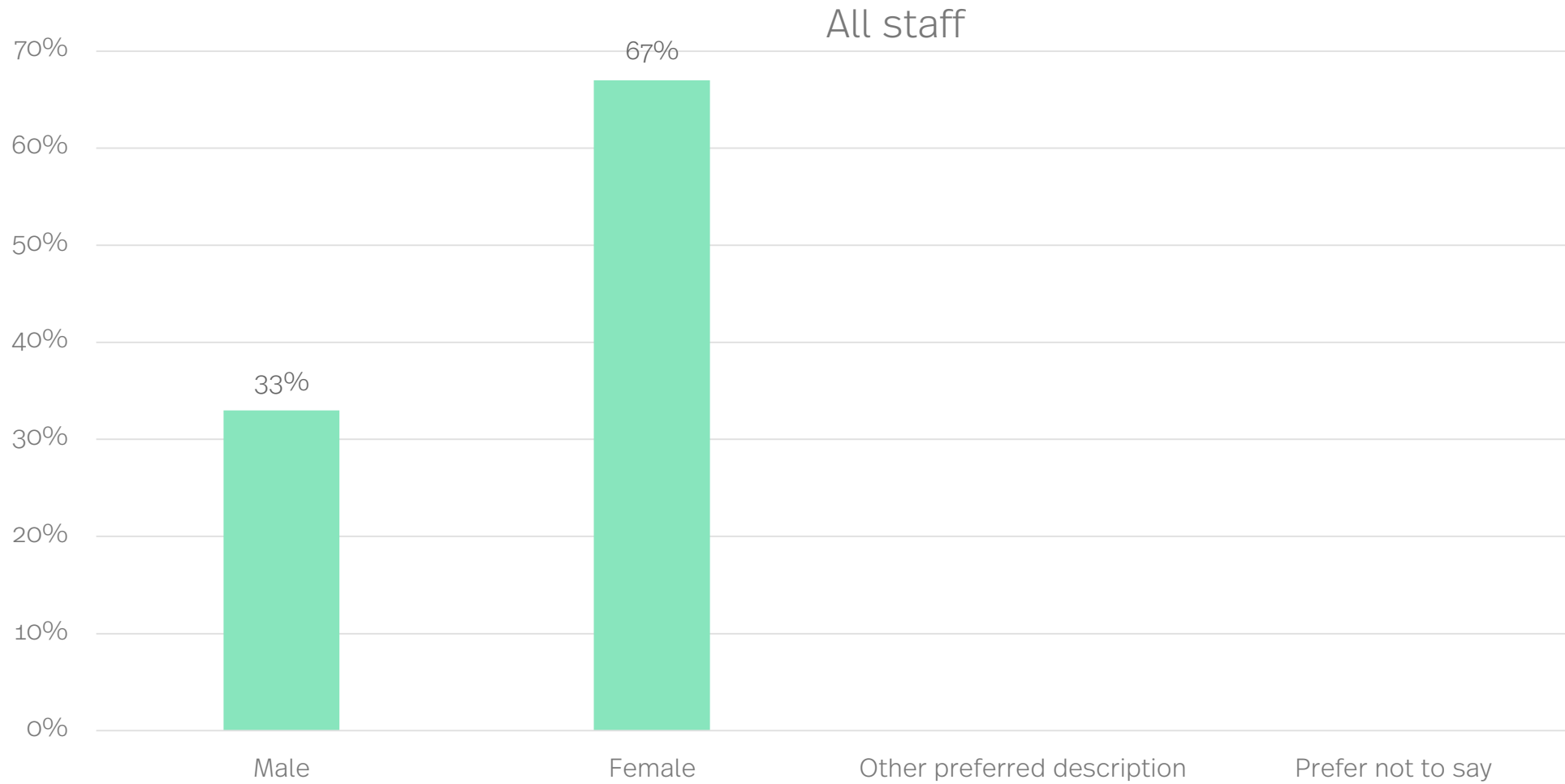

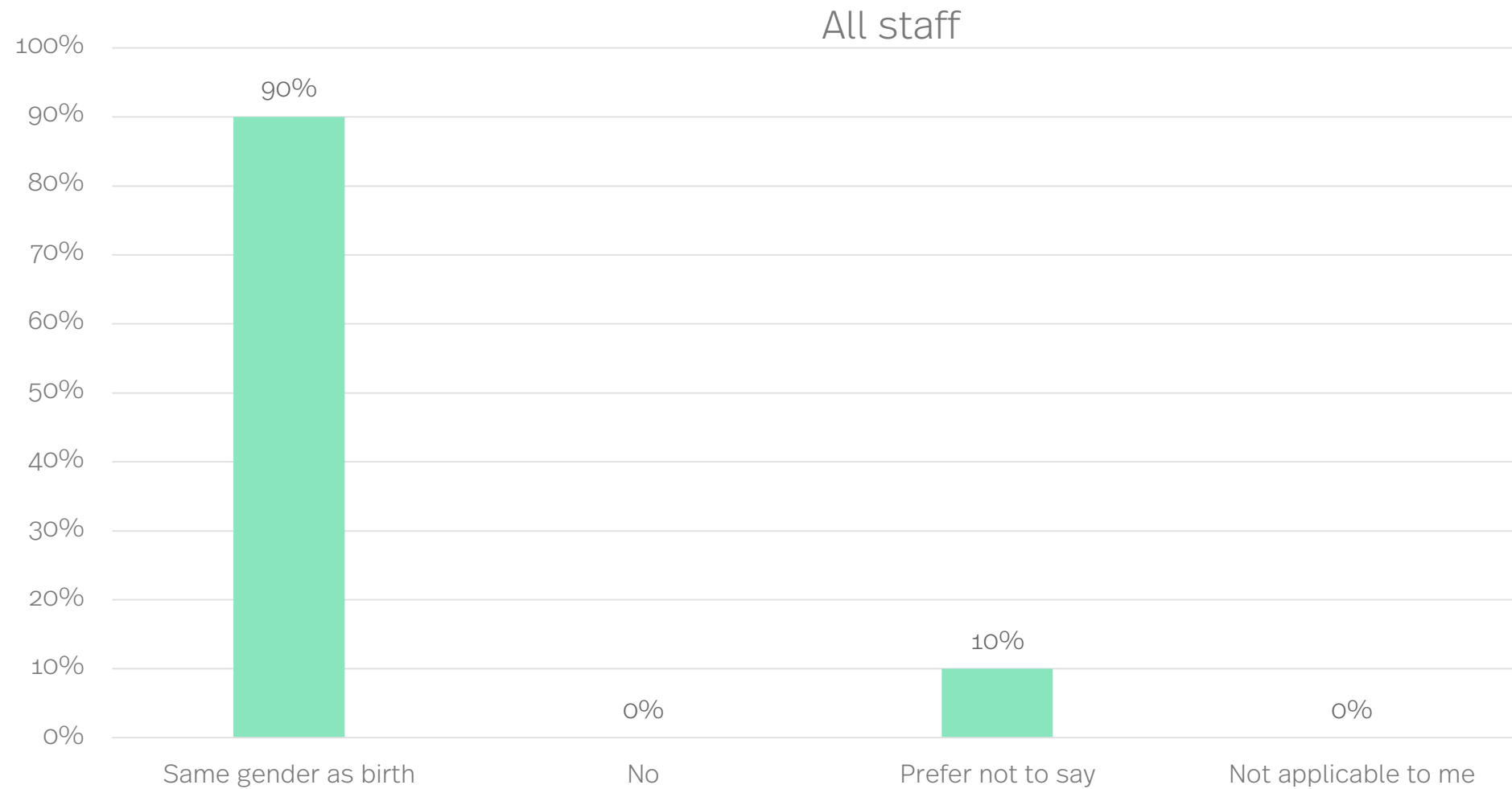

The completion rate in Asia for 2026 is 53%.



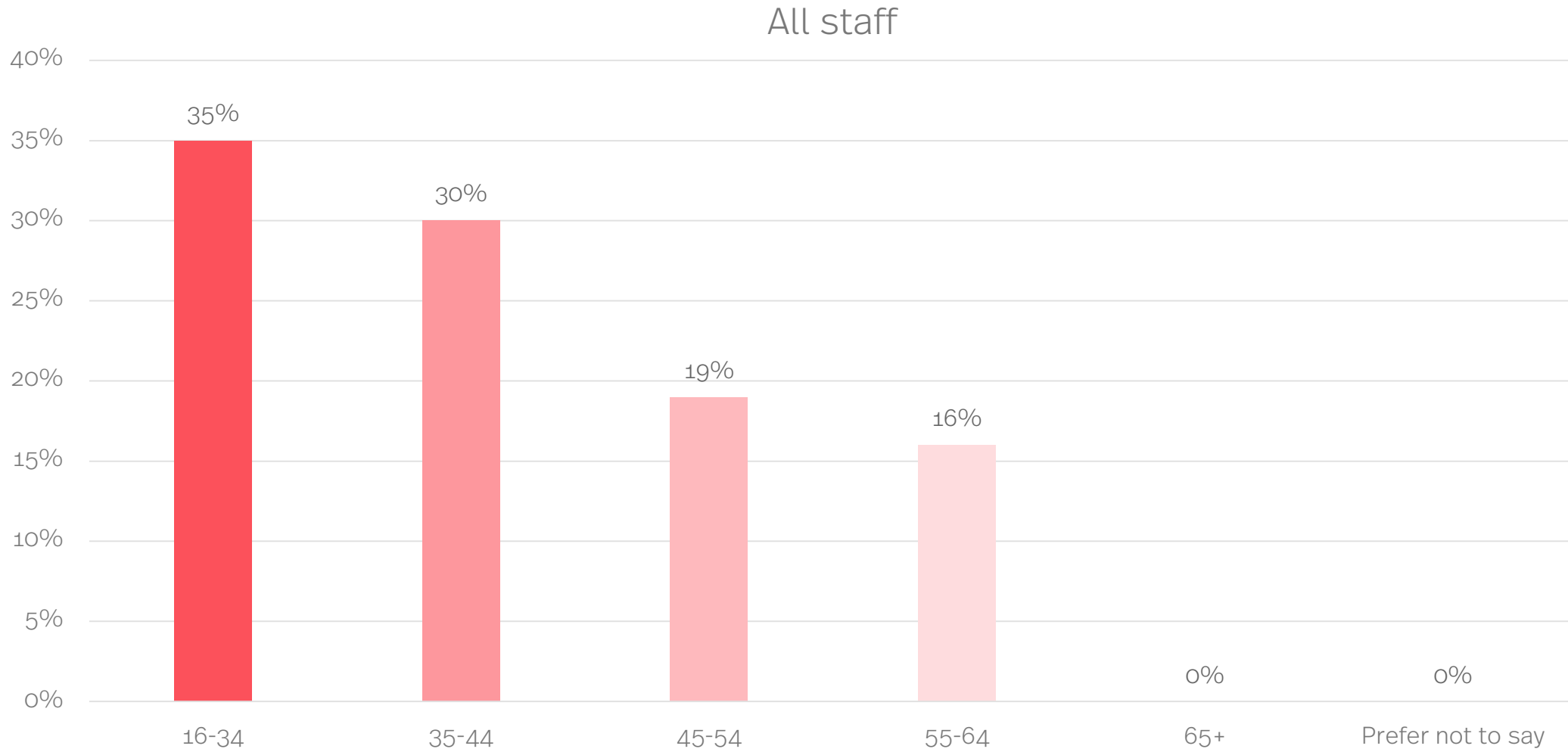
# Gender identity



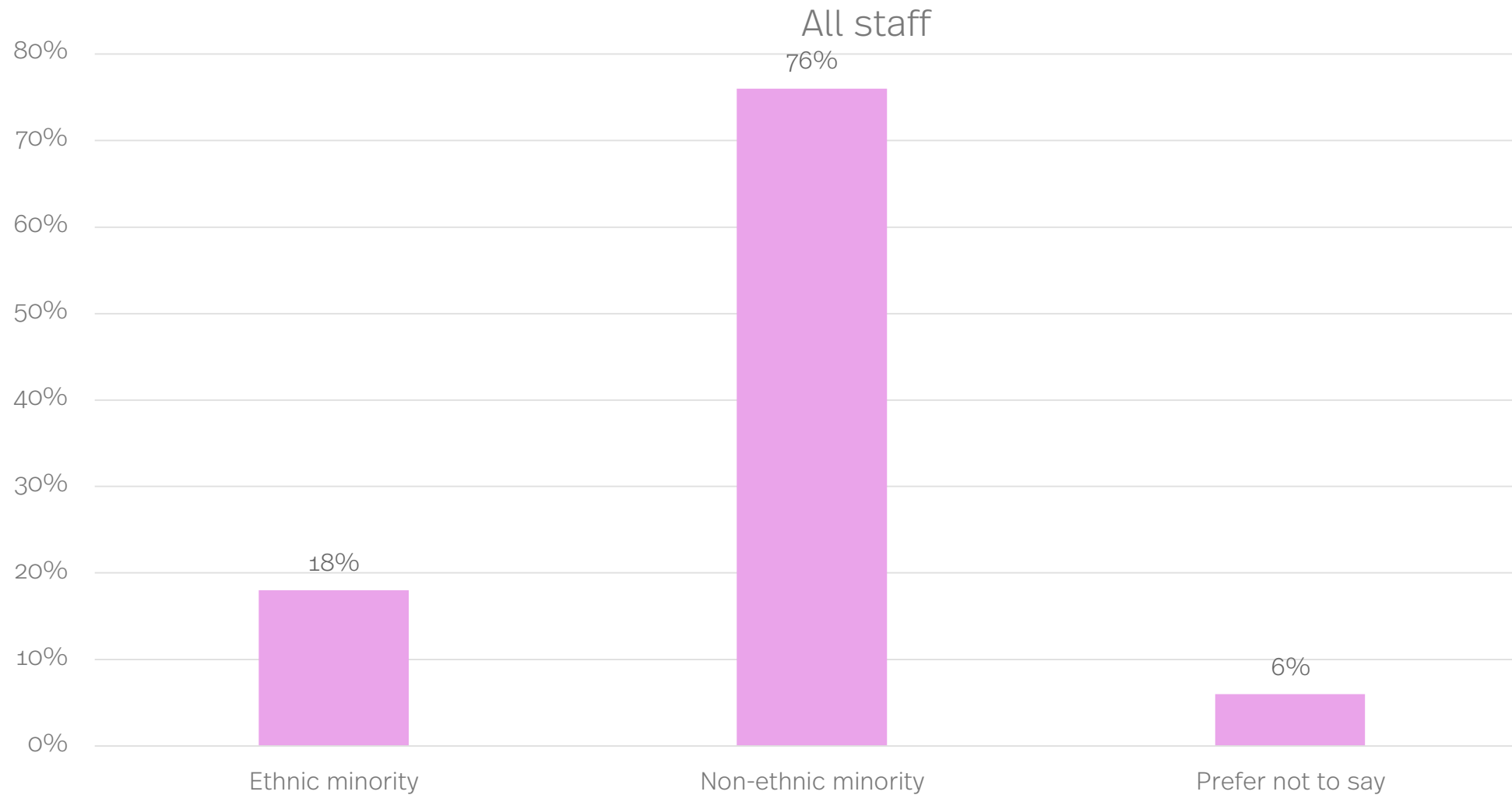
Is the gender you identify with (if any) the same as your sex at birth?

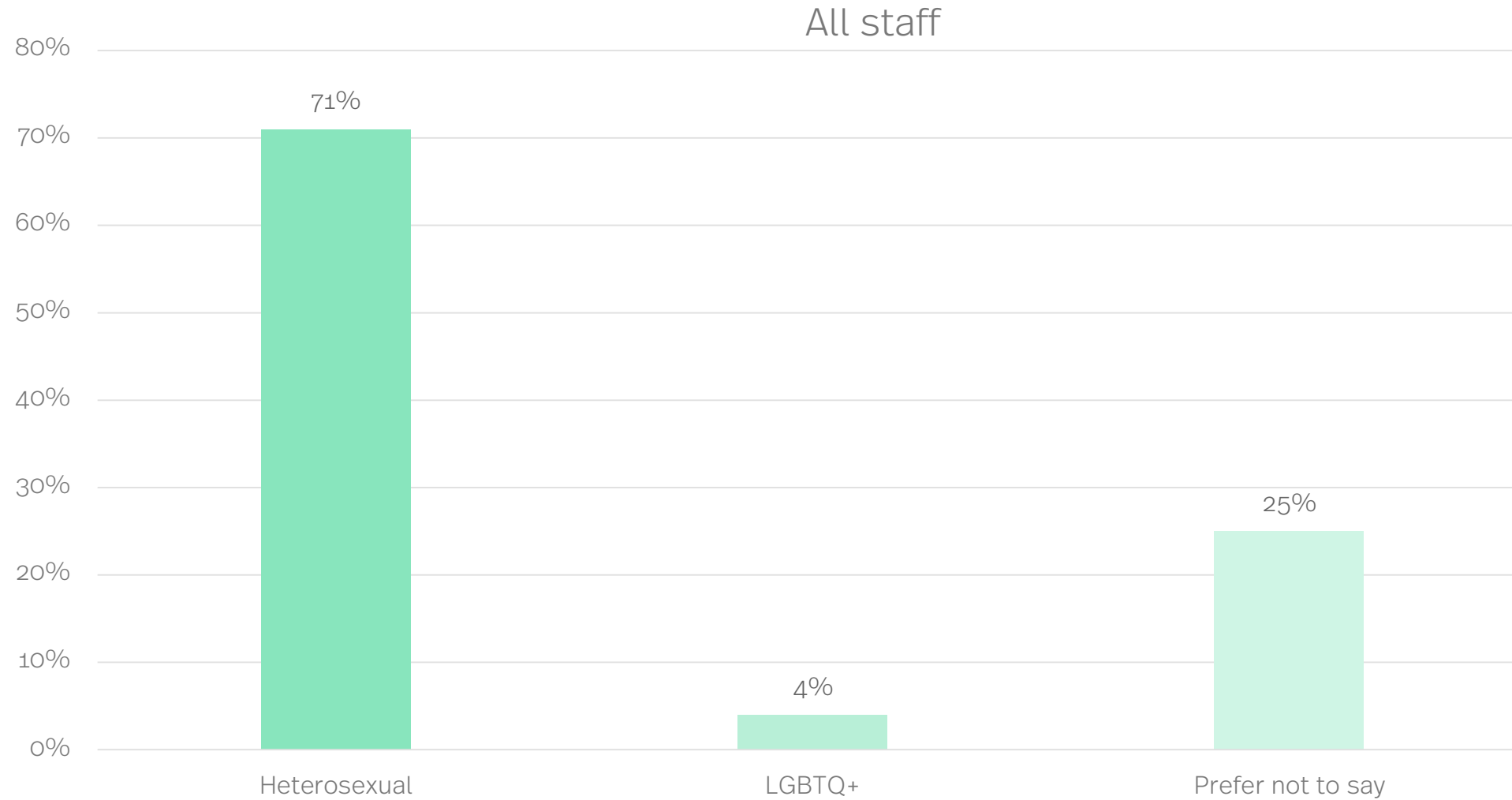


# Race/Ethnicity



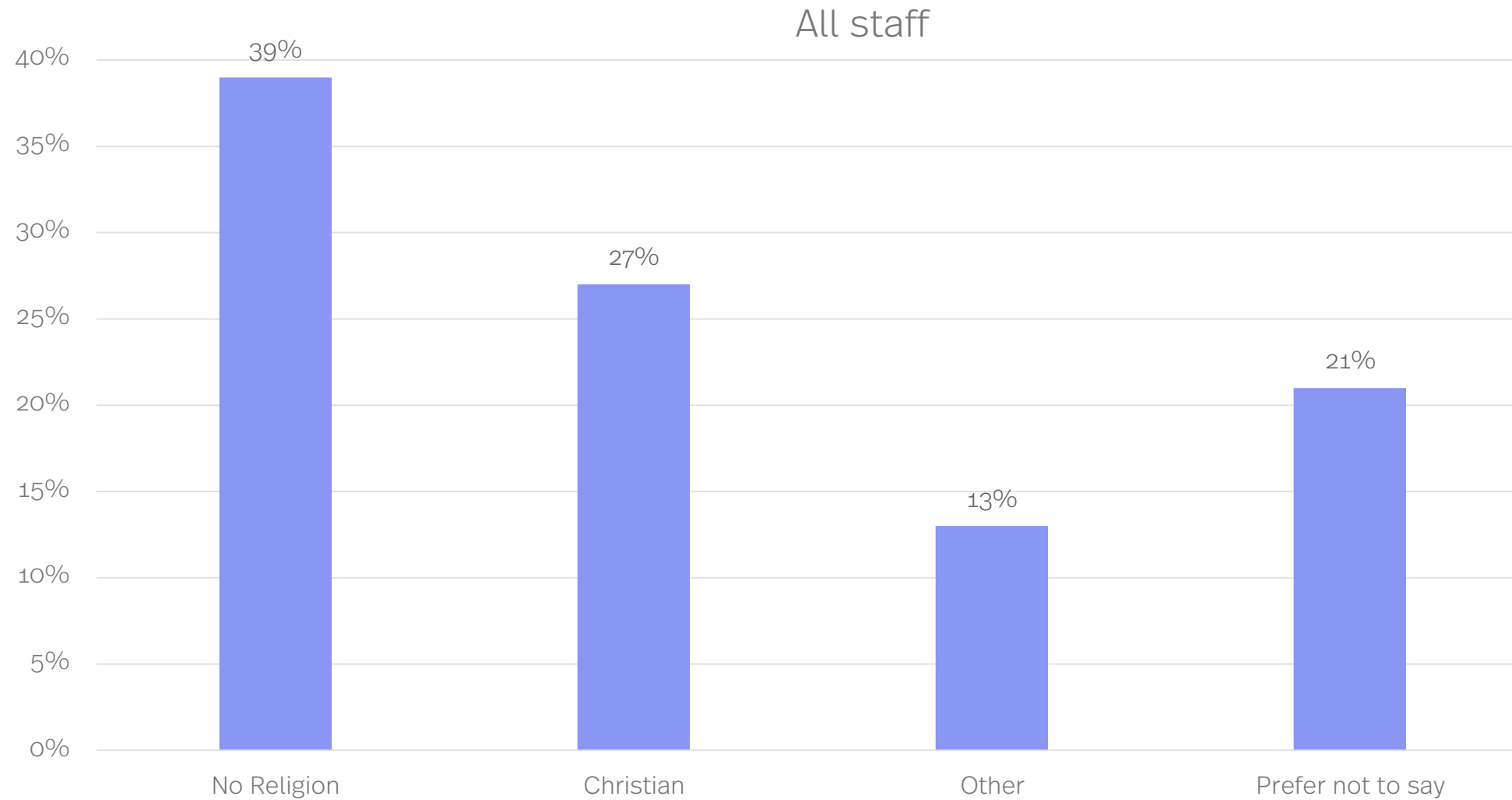

# Religion and belief

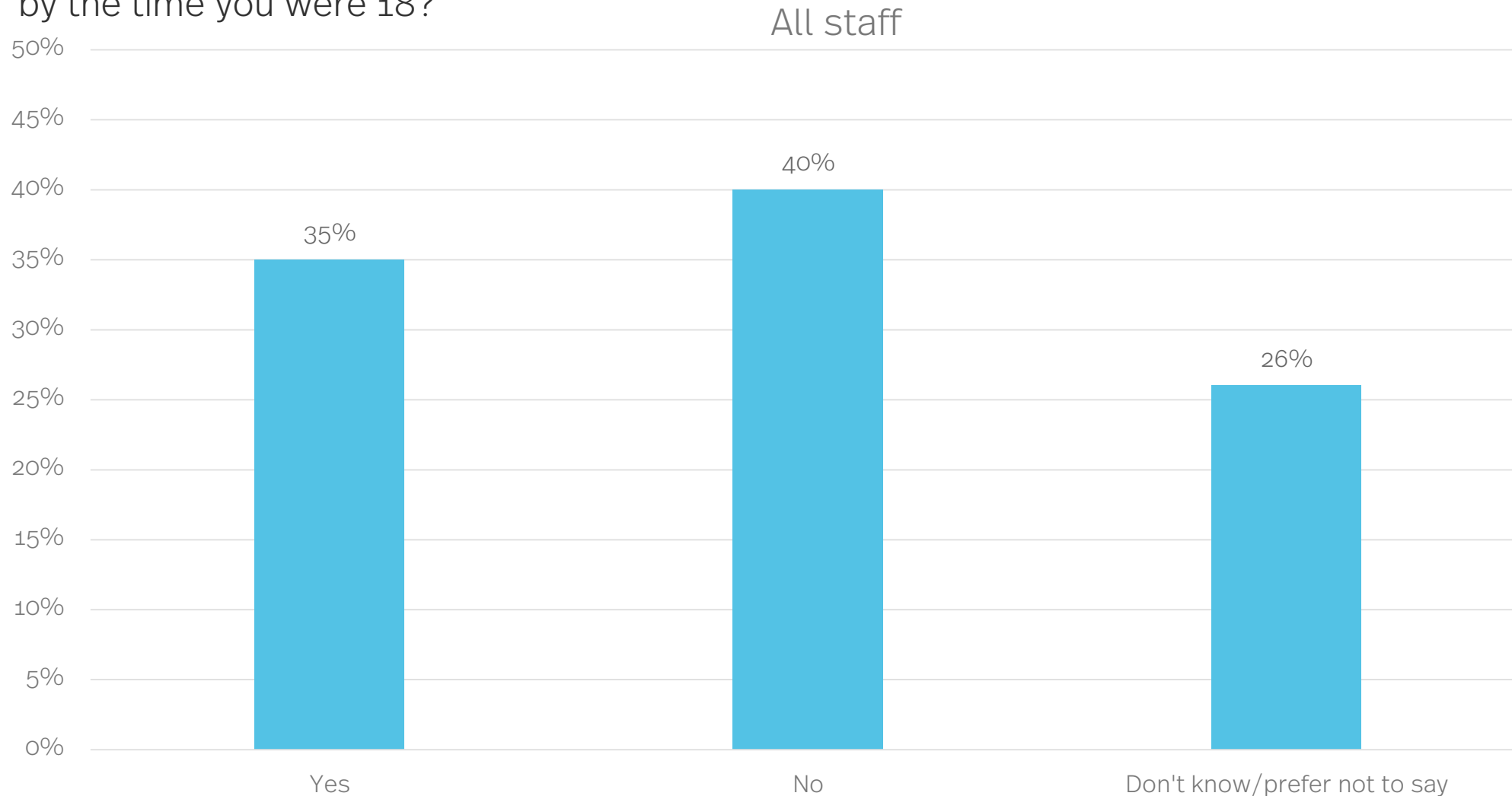

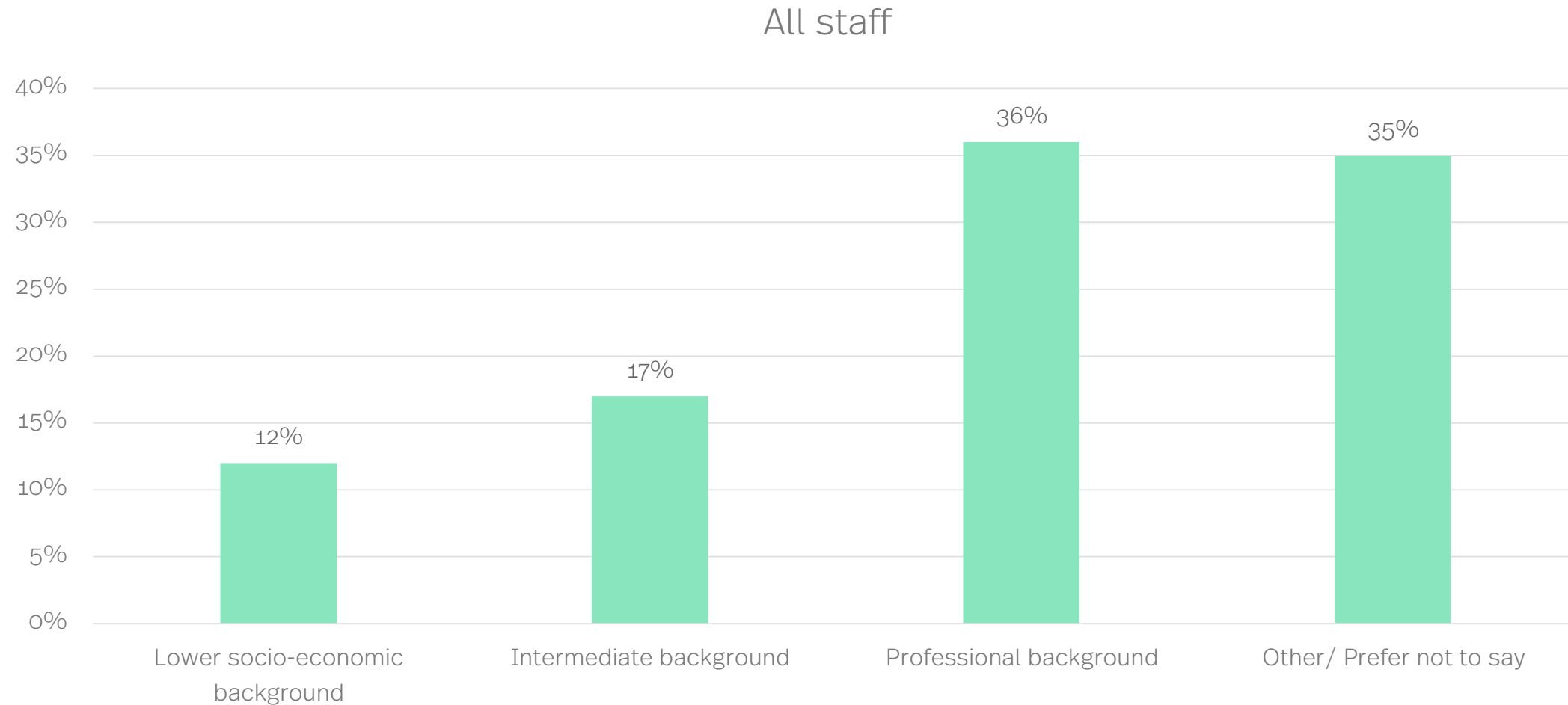
Did either of your parents attend university (or equivalent) and gain a degree (eg BA/BSc or equivalent) by the time you were 18?

Intermediate background: Option 3 (Clerical and intermediate occupations), Option 6 (Small business owners who employed less than 25 people)

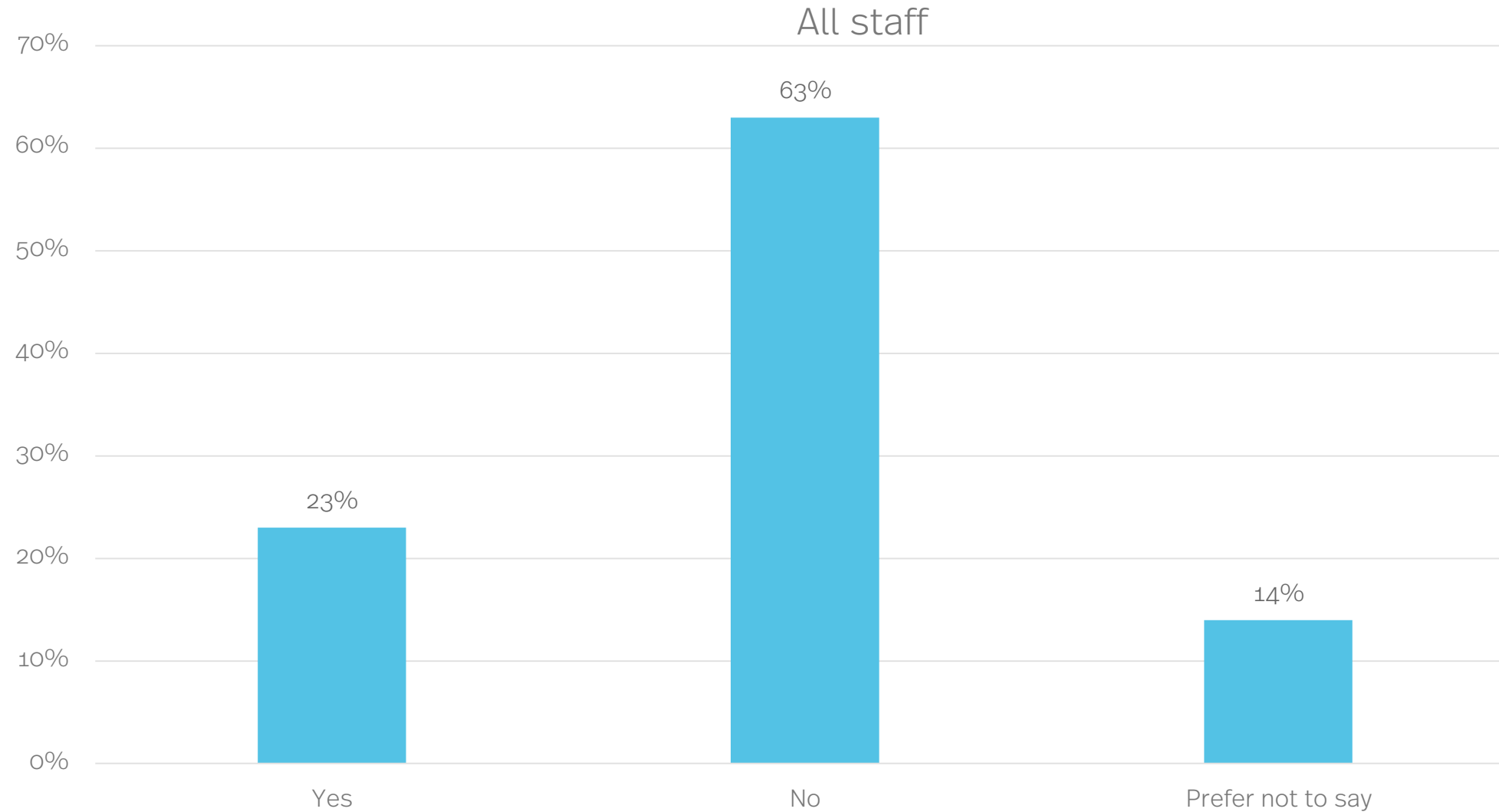
Professional background: Option 1 (Modern professional and traditional professional occupations), Option 2 (Senior, middle or junior managers or administrators)

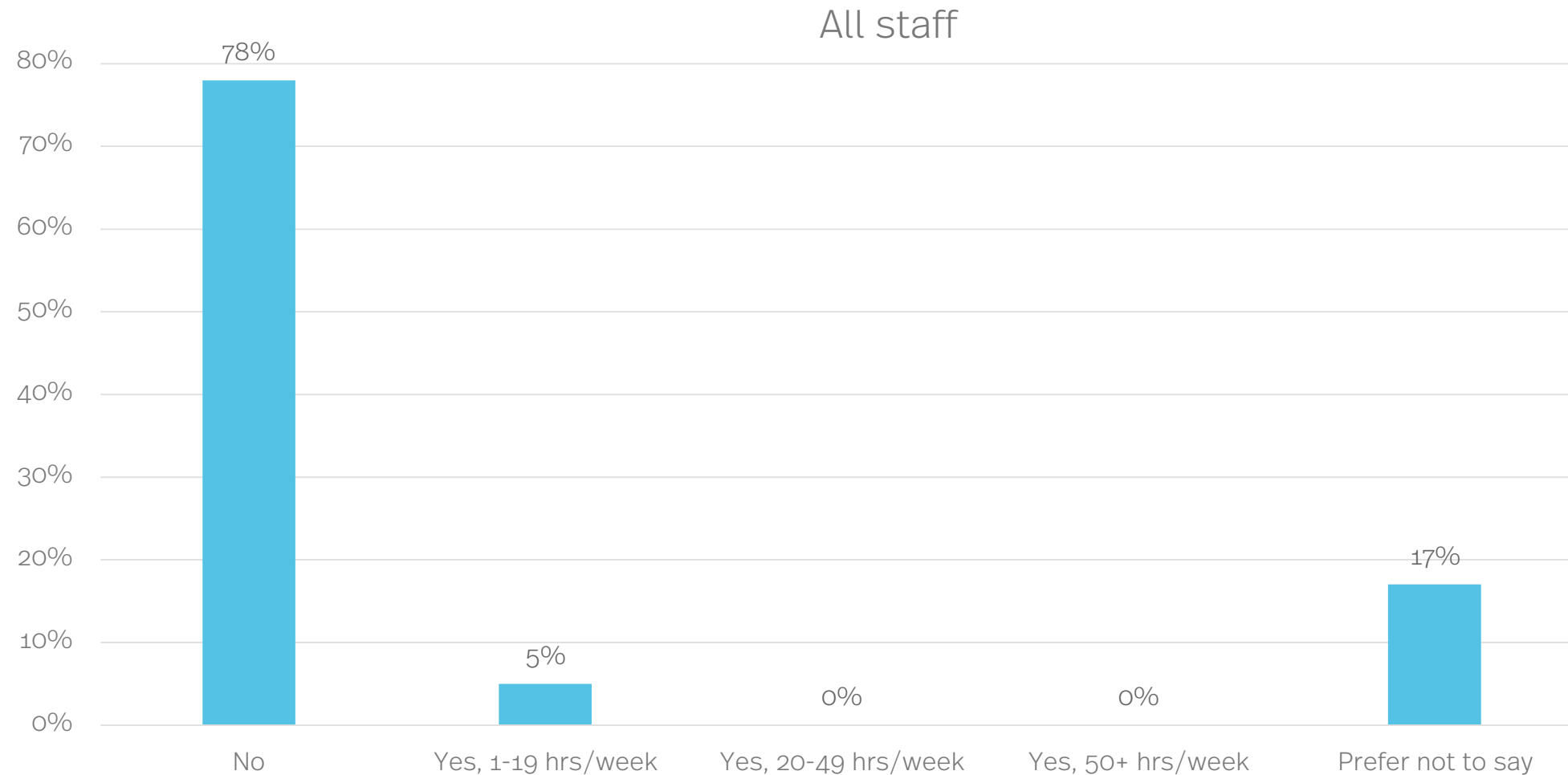
Are you a primary carer for a child or children under 18?

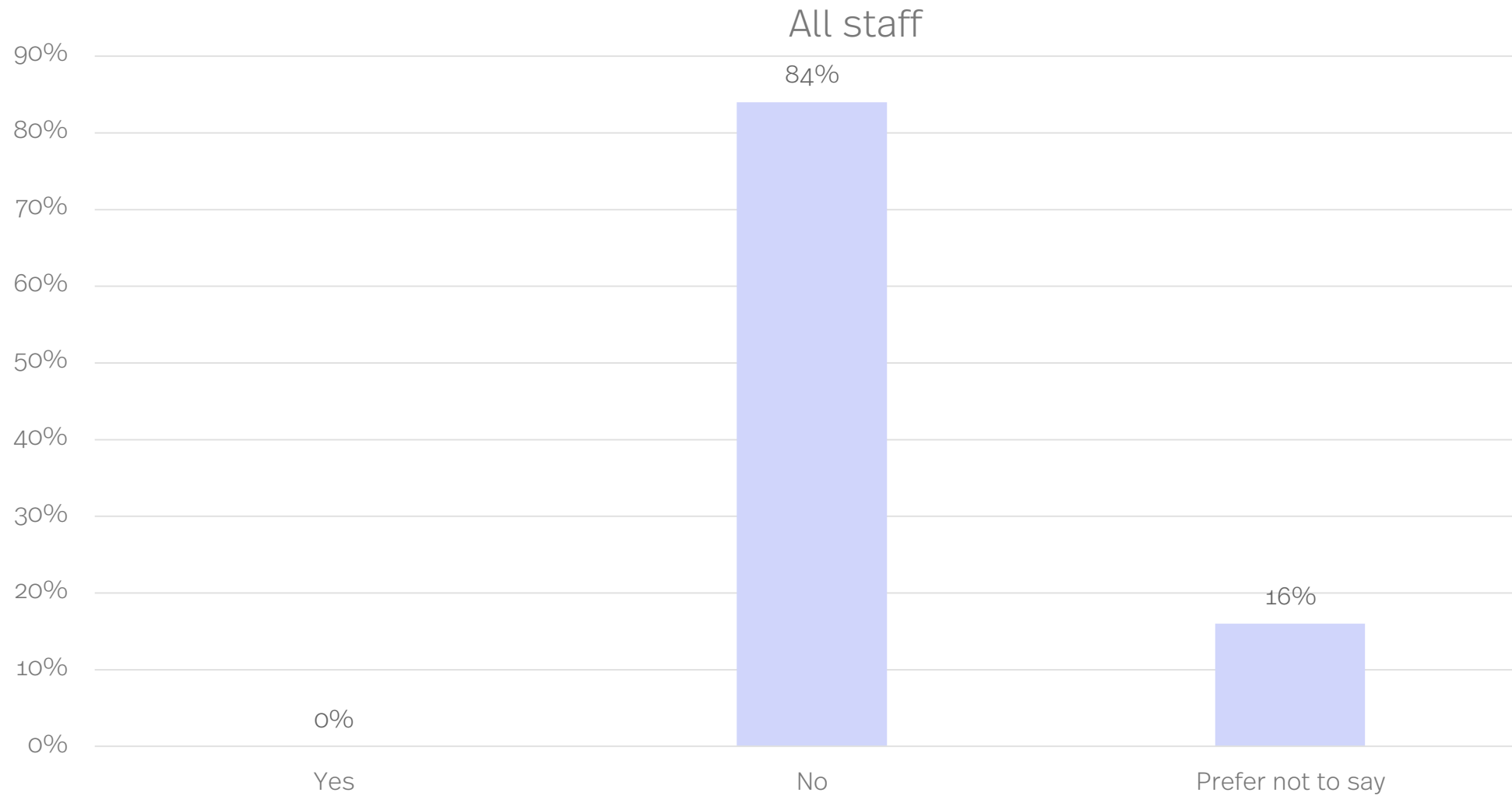


Do you look after or care for someone with long term physical or mental ill health caused by disability or age (not in a paid capacity)?

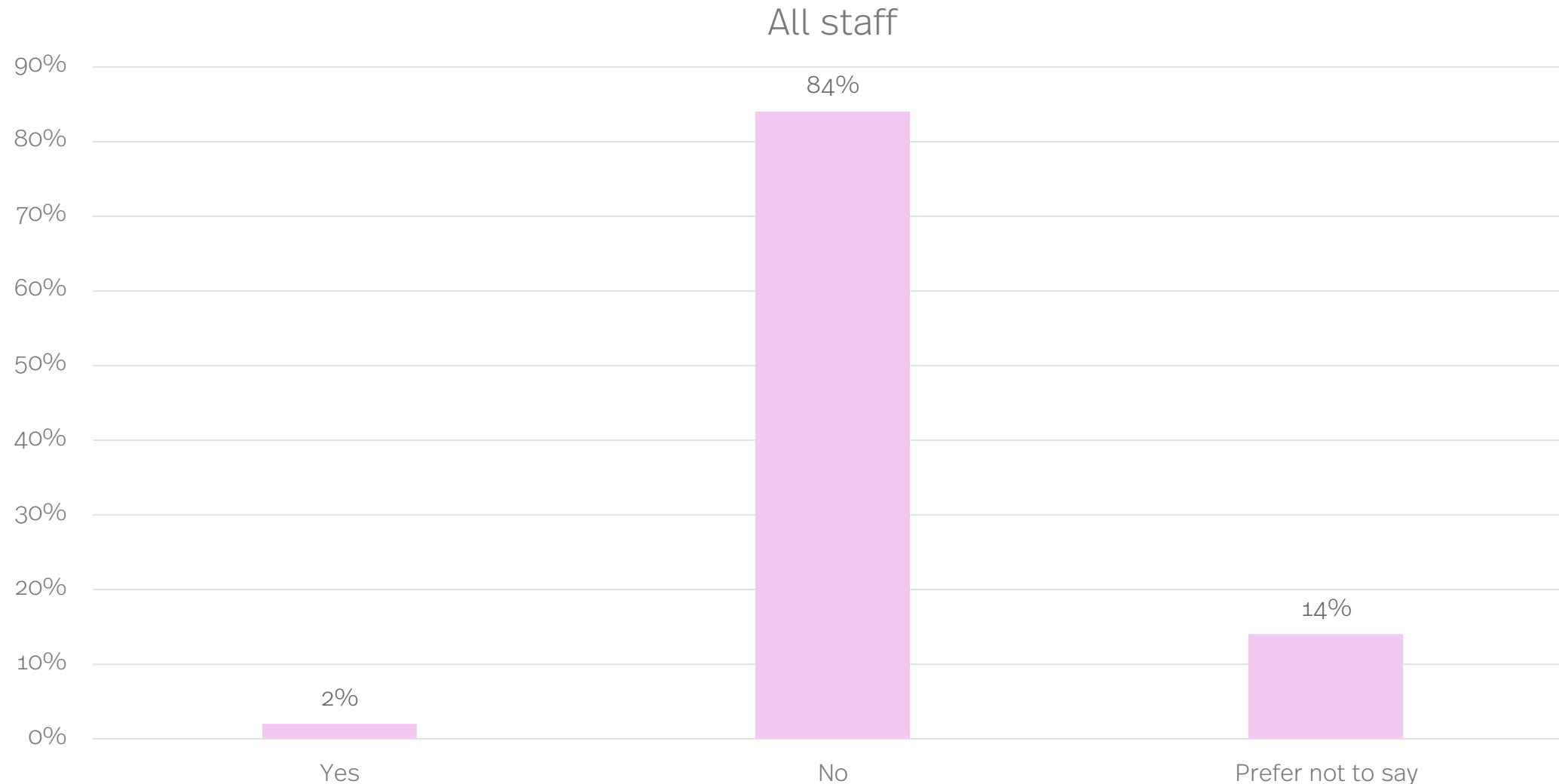
Are you neurodiverse?
