Subject to the provisions of these Rules, only the type and number of Prizes described in these Rules will be awarded in the Sweepstakes. If, due to printing, prizing, programming, production or other errors or for any other reason, the number of eligible entrants claiming the right to receive a Prize exceeds the number of Prizes available to be won as set out in these Rules, the Sponsor may, at its sole discretion, elect to award only the correct number of Prizes as described in these Rules by means a random drawing from among all such entrants making purportedly valid claims for such Prizes. - 20. CONSENT TO USE PERSONAL INFORMATION: The Sponsor respects your right to privacy.
