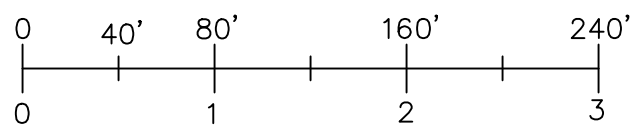


SITE LOCATION MAP
