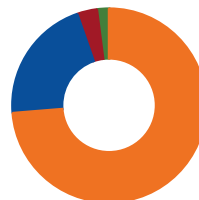

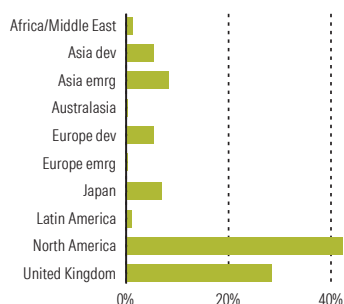

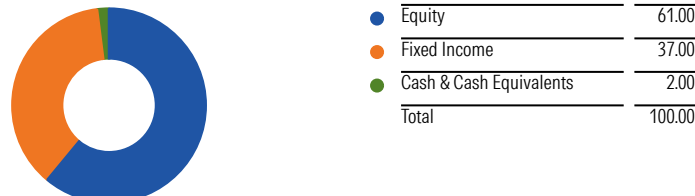

Asset Allocation



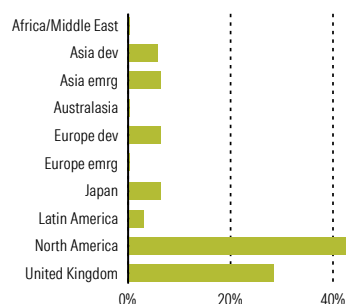

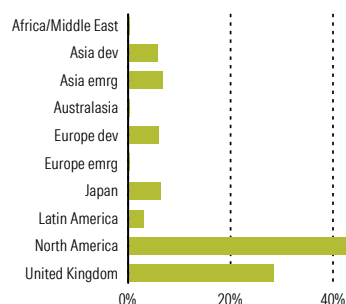

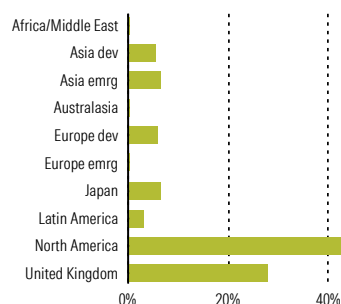

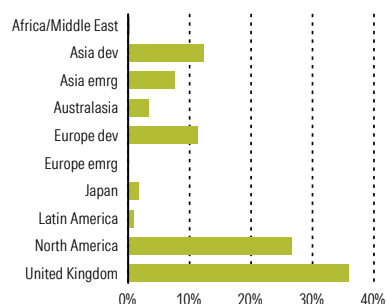

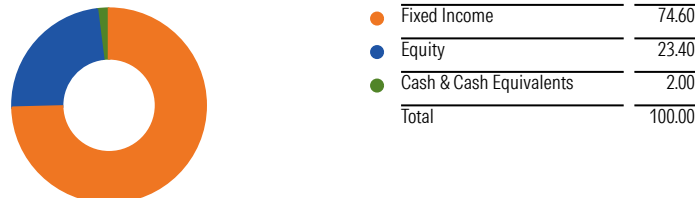

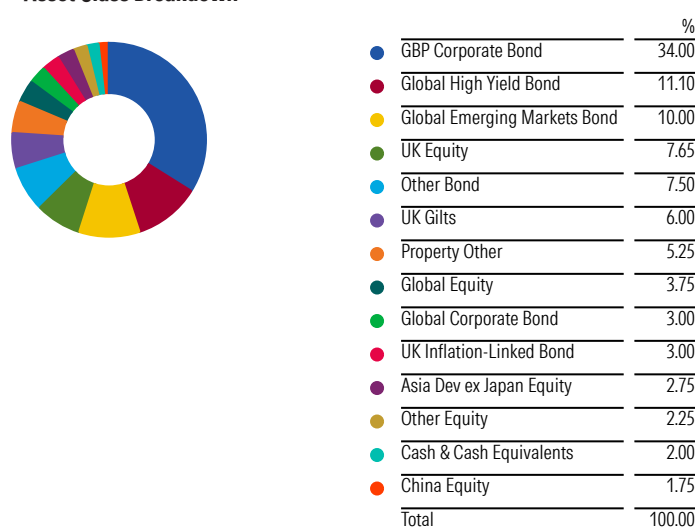
