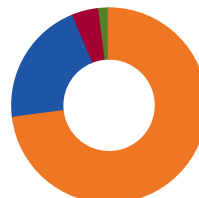

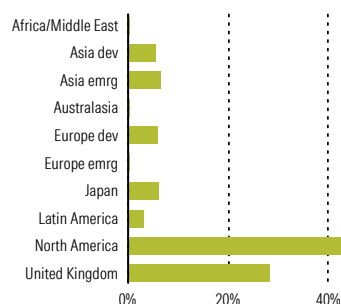

Asset Allocation



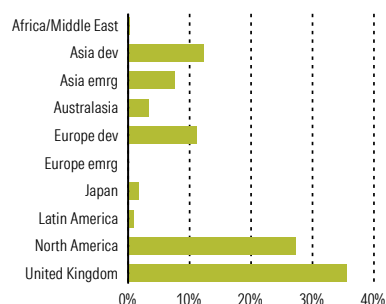
