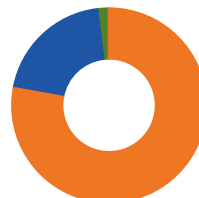

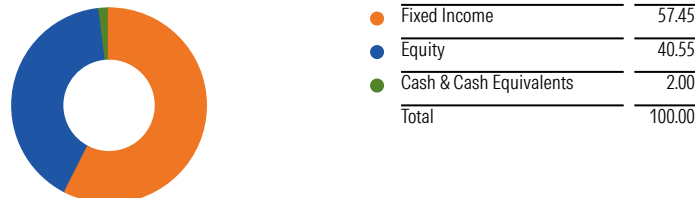

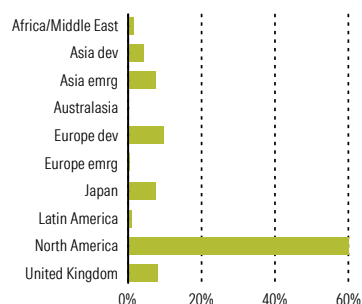

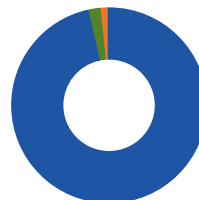

Asset Allocation



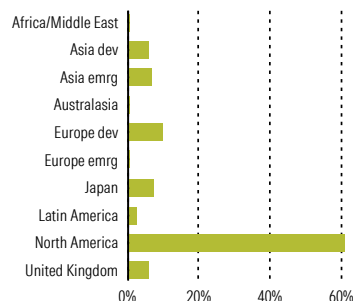
