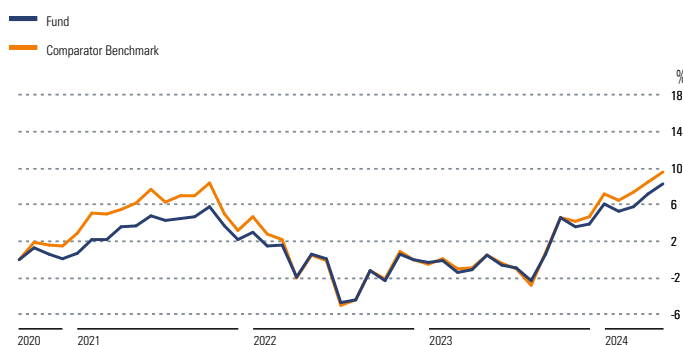

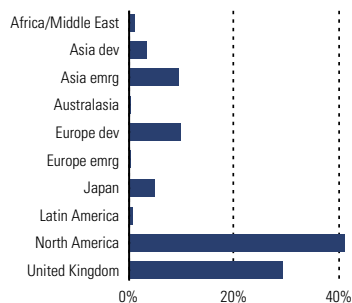

The Morningstar Style Box is a nine-square grid that illustrates the investment style of a security.
