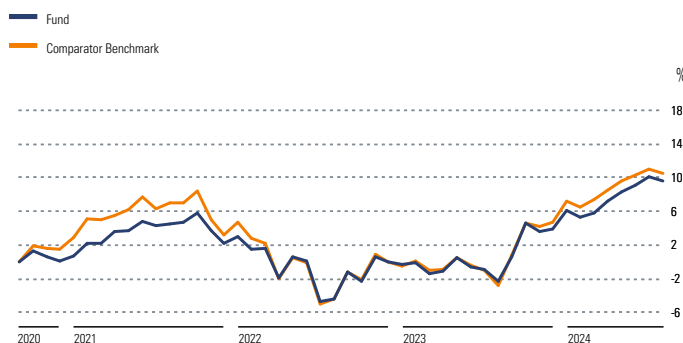

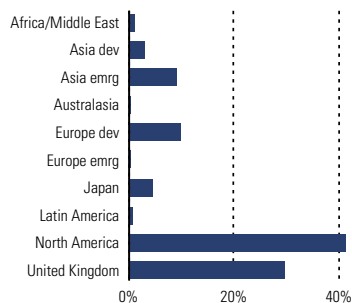

### Morningstar Equity Style Box (Look Through)\*

The Morningstar Style Box is a nine-square grid that illustrates the investment style of a security. For stocks, the central column of the Style Box represents the "core" style. Therefore, for funds, the central column represents the "blend" style (a mixture of growth and value stocks or mostly core stocks).
