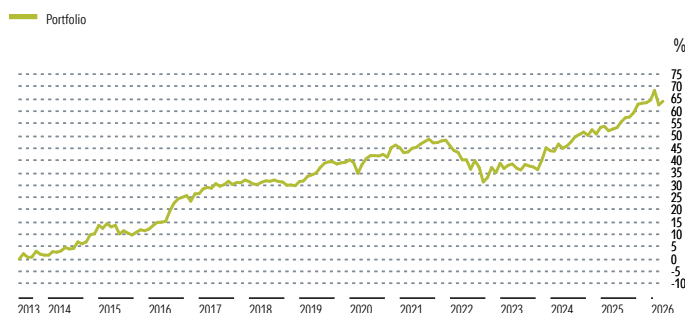

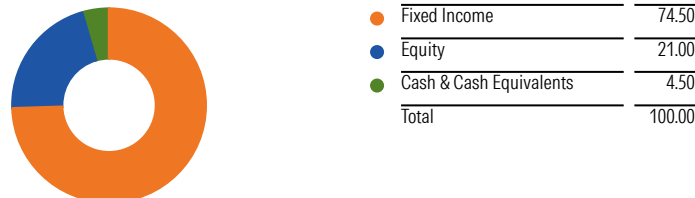

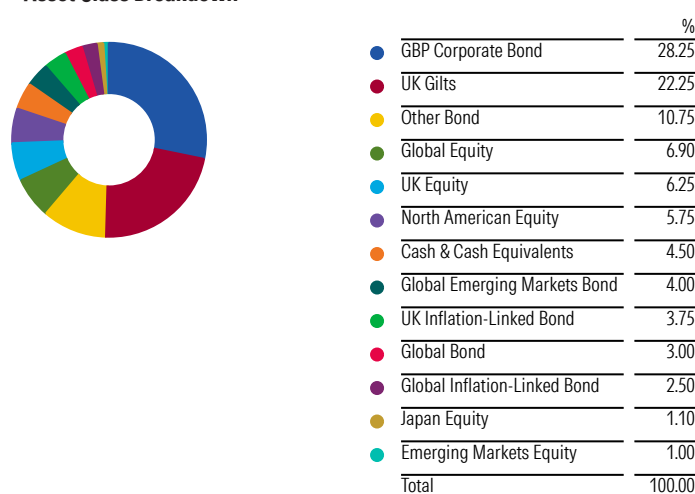

Asset Allocation



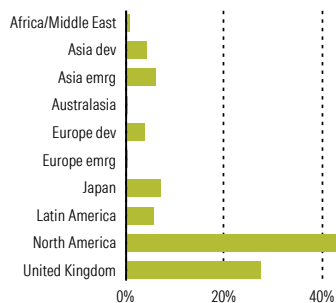

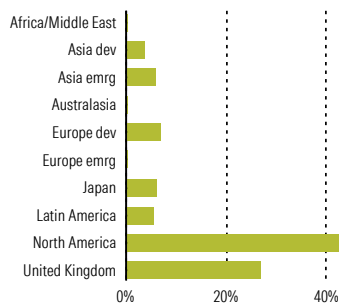

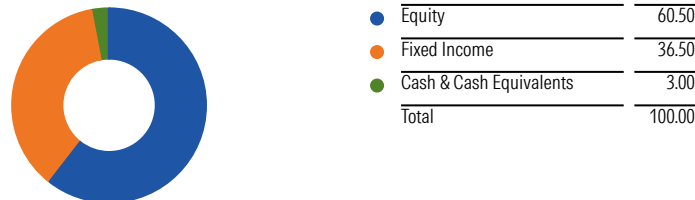

Asset Allocation



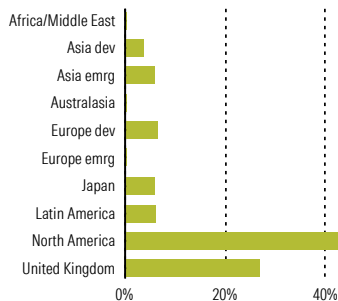

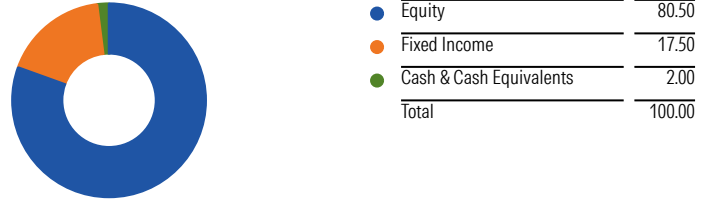

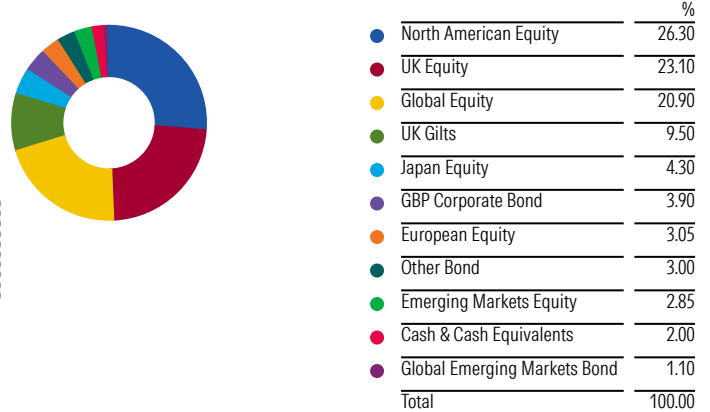

Asset Allocation



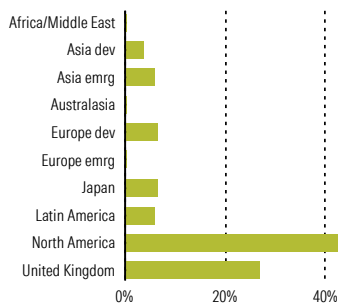

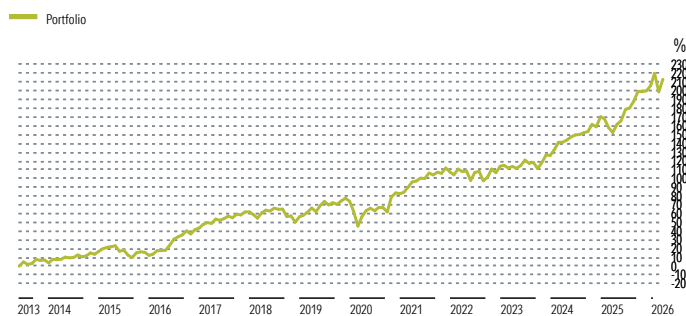

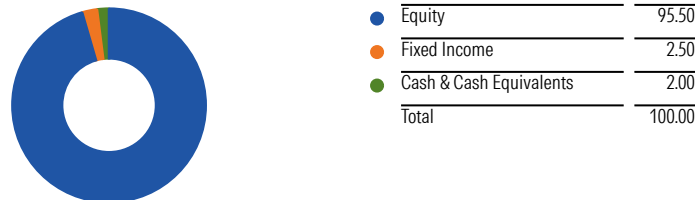

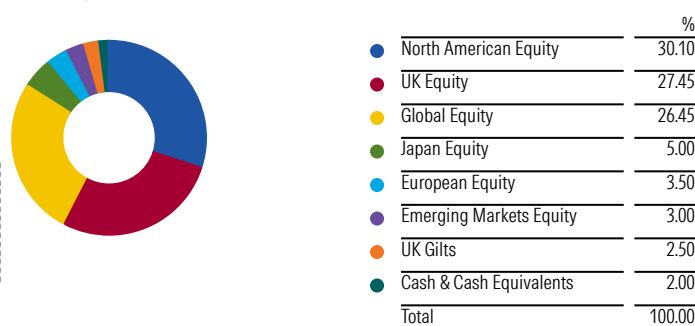

Asset Allocation



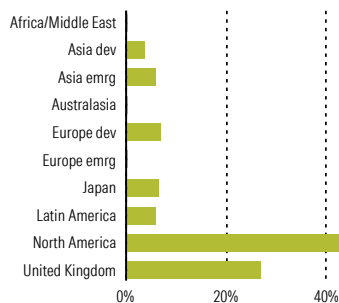
Asset Class Breakdown
