## 1. 合資格客戶

成功通過MoneyHero申請指定信用卡並完成本條款及細則所載的其他要求的合資格客戶將獲得推廣獎賞(定義如下)。

## 2. 推廣期

除非另有說明, 推廣期為2024/11/15 6pm至 2024/11/30 6pm(包括首尾兩天) (“推廣期”)。

## 3. 推廣活動相關定義

- a. “指定信用卡”指恒生enJoy卡。

e. “**Existing Customer Eligible Spending**” means HKD\$700

## 4. Eligible Customers

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.
