

(2024/09/02 6pm) MoneyHero x Sim Credit Card

1. 成功通過 MoneyHero 申請指定信用卡並完成以下要求的合資格客戶將獲得推廣獎賞(各自定義如下)。

2. 推廣期

除非另有說明, 推廣活動的推廣期為 2024/09/02 6pm至2024/09/30 6pm(包括首尾兩日)(「推廣期」)。

3. 推廣活動定義

4. 合資格客戶

為獲得推廣獎賞並成為「合資格客戶」, 客戶需:

4. Eligible Customers

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;

d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after receiving the MoneyHero Reward Redemption Form from MoneyHero;

e. Have their application for the Designated Card approved by the Product Provider on or before 2024/10/31, subject to the Product Provider’s system records; and

c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero within 90 days. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.
