

(2025/02/28 4pm) MoneyHero x Webull

1. 於推廣期內，透過MoneyHero申請指定帳戶，並獲批准且完成此處列明的其他要求的合資格客戶，將獲得推廣獎賞（各自定義如下）。

2. 推廣期

[^Net Cumulative Deposit = Total deposit amount - total withdrawal amount - total transferred-out amount, transfer-in amount and capital gains & losses are excluded. If any withdrawal (including interest earned on assets) during the retention period of the activity cause the net deposit to fall below the required amount, it will be ineligible to participate in the promotion. If the customer deposits or withdraws in currencies other than HKD, the Product Provider will convert the USD/RMB at its internal exchange rates. HKD:USD = 1:0.1274, HKD: Offshore RMB = 1: 0.8261]
