# MoneyHero x 信銀國際私人貸款條款及細則— 2025年1月申請獎勵(無須提取貸款) (「推廣活動」)

(2025/01/03 6pm - 2025/01/16 12pm) MoneyHero x Citic - Personal Loan - Application Incentive

1.客戶凡在推廣期內通過MoneyHero成功申請指定貸款並完成以下要求的合資格客戶,將獲得推廣獎賞(定義見下文)。

# 2. 推廣期
