

MoneyHero x Webull Securities HK 條款及細則 - Apple Store禮品卡/HKTVmall電子購物禮券/ Klook電子禮券/JBL Link 20 防水智能喇叭/ PHILIPS 飛利浦ADD6920 RO純淨飲水機/ Dyson Digital Slim Submarine 輕量乾濕全能洗地吸塵器 (/ INSTA360 x4 全景運動相機/LG 28L Dehumidifier with Ionizer變頻式離子殺菌智能抽濕機

(以下稱「推廣活動」) (2024年10月)

1. 於推廣期內，透過MoneyHero申請指定帳戶，並獲批准且完成此處列明的其他要求的合資格客戶，將獲得推廣獎賞 (各自定義如下)。

## 2. 推廣期

除非另有說明，推廣活動的推廣期為2024年9月30日 (下午4時) 至2024年10月31日 (下午3時59分)，包括首尾兩日 (以下稱「推廣期」)。

Terms and Conditions of MoneyHero x Webull Securities HK - Apple Gift Card / HKTVmall electronic Voucher / Klook Electronic Voucher / JBL Link 20 portable speaker/ PHILIPS ADD6920 RO Water Dispenser/ Dyson Digital Slim Submarine vacuum/ MICROSOFT Xbox Series X Game Console (the “Promotion”) (Oct 2024)

1. Eligible Customers who apply for a Designated Account through MoneyHero during the Promotion Period, are approved for the same and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

## 2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 30 Sep 2024 (4pm) to 31 Oct 2024 (3.59pm), dates inclusive (the “Promotion Period”).
