# MoneyHero x 大新保險 - Car Insurance Promotion (Aug - Sep 2025)(「條款及細則」)

根據本條款及細則,合資格用戶(定義如下)於推廣期內(定義如下),透過MoneyHero的網站成功投保指定汽車保險,即有機會獲得推廣獎賞(定義如下)。

#### 2. 推廣期
