

MoneyHero x 渣打銀行私人貸款 條款及細則 202505 申請獎賞優惠(無須提取貸款) (「推廣活動」)

202505 MoneyHero x Standard Chartered Personal Loan - Application Incentive

1. 客戶凡在推廣期內通過MoneyHero成功申請指定貸款並完成以下要求的合資格客戶，將獲得推廣獎賞(定義見下文)。

2. 推廣期

除非另有說明，推廣活動的推廣期為 2025/04/30 6pm 至 2025/05/29 6pm，包括首尾兩日(「推廣期」)。

3. 就此推廣活動而言：

- a. 「指定貸款」是指 渣打銀行私人貸款。
- b. 「產品提供者」是指 渣打銀行。

4. 合資格客戶

為了獲得推廣獎賞並成為「合資格客戶」，客戶需滿足以下條件：

- a. 為年滿18歲或以上、持有有效香港身份證及在香港有通訊地址的客戶；
- b. 在被重定向至產品提供者網站之前，向MoneyHero提供有效的電郵地址；
- c. 在推廣期內通過MoneyHero指定連結完整填寫並提交指定貸款的申請；
- d. 在收到MoneyHero獎賞換領表格後7天內完整填寫並提交MoneyHero獎賞換領表格；
- e. 客戶需同時向機構交齊所有文件並獲銀行確認其貸款申請。

5. 推廣獎賞及兌換

a. 完成第4條所列條件的合資格客戶將能選擇以下「推廣獎賞」之一，視供應情況而定：

- i. 貸款額 HK\$800,000 或以上：
 - HK\$800 Apple Store禮品卡；或
 - HK\$800 惠康購物現金券。

b. 合資格客戶將最多可獲得1個推廣獎賞。

c. 在確認資格後，兌換詳情將通過電子郵件發送至合資格客戶提供給MoneyHero的電郵地址。提供錯誤或不正確信息(由MoneyHero絕對酌情決定)的合資格客戶將無法收到任何推廣獎賞。

d. 推廣獎賞的資格將基於MoneyHero及產品提供者的內部記錄。在任何爭議情況下，MoneyHero保留絕對酌情決定的最終權利，對所有用戶具有約束力。

1. Eligible Customers who successfully apply for a Designated Loan through MoneyHero during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2025/04/30 6pm to 2025/05/29 6pm, dates inclusive (the “**Promotion Period**”).

3. For the purposes of this Promotion:

- a. “**Designated Loan**” means the Standard Chartered Personal Instalment Loan.
- b. “**Product Provider**” means Standard Chartered.

4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

- a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;
- b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;
- c. Fully complete and submit an application for a Designated Loan through MoneyHero using the designated link during the Promotion Period;
- d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after receiving the MoneyHero Reward Redemption Form from MoneyHero;
- e. Submit all documents to the Product Provider and have their application for the Designated Loan confirmed by the Product Provider.

5. Promotion Rewards and Redemption

a. Eligible Customers who complete the conditions set out in Clause 4 above will be able to select one of the following “**Promotion Rewards**”, subject to availability:

- i. Loan amount from HK\$800,000 or above:
 - HK\$800 Wellcome Shopping Voucher; OR
 - HK\$800 Apple Store Gift Card.

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.

d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers’ internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.

e. If the application for the Designated Loan is not made via the designated link, or an ad-blocker, tracking blocker or incognito mode is enabled during the application process, it may not be counted as valid and

may lead to the user not being eligible for any Promotion Reward. MoneyHero reserves the right to withhold any Promotion Reward where, according to its records, the application was not made through MoneyHero in accordance with these Terms and Conditions.

f. Promotion Rewards are not refundable nor exchangeable for cash or other rewards. All products and services relating to the Promotion are available while stocks last. Eligible Customers are responsible for checking the quality of the Promotion Rewards at the time of redemption. k. Users who do not submit the MoneyHero Reward Redemption Form within the specified period will not be eligible to receive the Promotion Reward, even if they fulfill all other conditions.

l. Users who provide inaccurate or incorrect information in the MoneyHero Reward Redemption Form (as determined by MoneyHero acting in its absolute discretion) will not be able to receive the Promotion Reward.

m. Where a Promotion Reward is available in multiple colours or other cosmetic variations, Eligible Customers will not be able to select a colour and will receive one at random.

n. The general redemption process set out on the MoneyHero Website shall not apply to this Promotion. The redemption process for the Promotion Reward shall be governed solely by the Terms and Conditions of this Promotion.

The redemption process may take at least 8 weeks starting from the date on which the eligibility is confirmed by the Product Provider, depending on the actual situation regarding delivery or redemption arrangements, user approval and transaction status or other factors that may affect eligibility for the Promotion Reward.

p. Any Promotion Reward(s) not claimed past the stipulated collection period (if any) be forfeited without any liability on the part of MoneyHero to the Eligible Customer. Any Eligible Customer whose Promotion Reward has been forfeited shall not be entitled to any payment or compensation in lieu from MoneyHero.

q. Any queries regarding redemption, or redemption submissions of the Promotion Reward that are received more than 6 months after the end of the Promotion Period will not be handled, except for those already in progress.

r. Apple is not a participant in or sponsor of this Promotion.

- a. This Promotion is organised by MoneyHero Global Limited (“**MoneyHero**”). By participating in this Promotion, users agree to be bound by these Terms and Conditions.
- b. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.
- c. MoneyHero reserves the right to amend these Terms and Conditions at any time, including changing the Promotion Period or Promotion Reward or to terminate this Promotion with or without prior notice or liability to users.
- d. In the event of any inconsistencies between these Terms and Conditions and any other materials (e.g marketing materials) relating to this Promotion, these Terms and Conditions shall prevail.
- e.
