



"MHNYRFS" Invitation Code Promotion (the "Promotion") Terms and Conditions

- These terms apply to the Promotion offered by Mox Bank Limited ("Mox", "we", "us" or "our"). By participating in the Promotion, you agree to these terms.
- You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (including the schedules thereto), each of which can be found in the Mox app and/or on our website, and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services.
- 3. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- 4. Unless defined in these terms or the context requires otherwise, capitalised terms have the meanings given to them in our General Terms and Conditions.
- 5. If you:
 - (a) during the Promotion Period, use the Invitation Code to open a Mox Account:
 - (b) during the period beginning on and from the day you use the Invitation Code and the following 15 days, complete the Mox Account opening process (you will have 'completed' the Mox Account opening process once you have received a welcome notification from Mox (the day on which you receive your welcome notification, your "Joining Day");
 - (c) during the period beginning on and from the day you use the Invitation Code and the following 60 days, complete the Mox Credit application process (you will have 'completed' the Mox Credit application process once you have received a Mox Credit approval notification from Mox (the day

subject to these terms, you will receive the successful application number, which we will deliver to you via email within 14 business days, following the day you satisfy all the requirements set out in clause. We will send the email to your email address that is in our records. You must use your Reward within the designated period, otherwise you will forfeit your right to the Reward. This Reward is provided by MoneyHero. For the details of designated period, please refer to the Terms and Conditions provided by MoneyHero.

- 6. You can only participate in the Promotion once. You can only receive one Reward.
- 7. The use of the Invitation Code is subject to a quota of 2,000 uses. The 'Promotion Period' will end on the earlier of: (a) the last day of that period, and (b) the day on which the Invitation Code has been used 2,000 times. The use of the Invitation Code is on a first come, first served basis (as determined by us in our absolute discretion). We will not update you on the quota usage or its continued availability.
- 8. We will determine whether an Eligible Transaction has occurred based on transaction records held by us (which are final and conclusive in case of any discrepancy).

- (g) "Spending Requirement" has the meaning given in clause 5(d) of these terms.
