

MoneyHero x 信銀國際私人貸款條款及細則– 2025年1月申請獎勵(無須提取貸款) (「推廣活動」)

(2025/01/16 12pm - 2025/01/24 12pm) MoneyHero x Citic - Personal Loan - Application Incentive

1. 客戶凡在推廣期內通過MoneyHero成功申請指定貸款並完成以下要求的合資格客戶，將獲得推廣獎賞(定義見下文)。

2. 推廣期

除非另有說明，推廣活動的推廣期為2025/01/16 12pm至2025/01/24 12pm，包括首尾兩日(「推廣期」)。

3. 就此推廣活動而言：

a. 「指定貸款」是指信銀國際 \$mart Plus 分期貸款 (稅季優惠)及信銀國際 \$mart Plus 分期貸款。

b. 「產品提供者」是指信銀國際。

4. 合資格客戶

為了獲得推廣獎賞並成為「合資格客戶」，客戶需滿足以下條件：

- a. 為18歲或以上，持有有效香港身份證且在香港有通訊地址的客戶；

5. 推廣獎賞及兌換

e. Have their application for the Designated Loan approved by the Product Provider and complete drawdown for the Designated Loan within 1 month;
