

## MoneyHero x Mox 條款及細則 - 「推廣活動」(2025/1/10 6pm - 2025/1/17 6pm)

1. 於推廣期內, 透過MoneyHero申請指定帳戶, 並獲批核且完成此處列明的其他要求的合資格客戶, 將獲得推廣獎賞(各自定義如下)。

### 2. 推廣期

除非另有說明, 推廣活動的推廣期為2025/1/10 6pm至2025/1/17 6pm, 包括首尾兩日(以下稱「推廣期」)。

### 3. 本推廣活動而言:

a. 「指定帳戶」是指Mox戶口。

b. 「相關金融機構」是指Mox。

## Terms and Conditions of MoneyHero x Mox - **Promotion** (2025/1/10 6pm -2025/1/17 6pm)

1. Eligible Customers who apply for a Designated Account through MoneyHero during the Promotion Period, are approved for the same and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

### 2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2025/1/10 6pm to 2025/1/17 6pm, dates inclusive (the "**Promotion Period**").

3. For the purposes of this Promotion:

a. "**Designated Account**" means the Mox Account..

b. "**Product Provider**" means Mox.

c. "**New Customer**" means who have not held a Mox Account in your name at any time in the 12-month prior to your Joining Day. You are considered to have held a Mox Account even if you haven't completed any transactions on your prior Mox Account.

d. "**Promo Code**" means "MOX4100MHFS".

### 4. Eligible Customers

To qualify for the promotional rewards and become an "Eligible Customer," customers must:

a. Be a new customer who is at least 18 years old, holds a valid Hong Kong identity card, and has a Hong Kong correspondence address;

b. Provide MoneyHero with a valid email address before being redirected to the relevant financial institution's website;

c. During the promotional period, use the designated link through MoneyHero to complete the application for the specified account with the invitation code, and receive a successful application email from Mox Bank (which contains the "successful application number");

d. Successfully obtain the Mox credit card within 30 days after opening the account (approval is based on bank system records). After approval, a "Reward Redemption Form" will be sent via email from MoneyHero, which must be completed and submitted within 14 days;

e. To receive the promotional rewards, customers must accumulate HK\$15,000 in spending within 60 days after the card approval for the specified account.
