

## 1. 合資格客戶

成功通過MoneyHero申請指定信用卡並完成本條款及細則所載的其他要求的合資格客戶將獲得推廣獎賞(定義如下)。

## 2. 推廣期

除非另有說明, 推廣期為2024/10/18 6pm至 2024/10/31 6pm(包括首尾兩天) (“推廣期”)。

## 3. 推廣活動相關定義

- a. “指定信用卡”指恆生MMPOWER World Mastercard。
- b. “信用卡提供者”指恆生銀行。
- c. “新客戶”指在申請指定信用卡前 12 個月內未持有恆生銀行任何信用卡的客戶。
- d. “新客戶合資格簽賬”指HKD\$1,000。
- e. “舊客戶合資格簽賬”指HKD\$700

## 4. 合資格客戶條件

為獲得推廣獎賞並成為“合資格客戶”, 客戶需:

c. “**New Customer**” means customers who have not held any credit card with Hang Seng Bank in the 12 months preceding the date on which their application for a Designated Card is made as part of this Promotion.

d. “**New Customer Eligible Spending**” means HKD\$1,000

e. “**Existing Customer Eligible Spending**” means HKD\$700.

## 3. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;

c. Fully complete and submit an application for a Designated Card through MoneyHero using the designated link during the Promotion Period;

d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after receiving the MoneyHero Reward Redemption Form from MoneyHero; and

e. **Within 30 days after card issuance: The card must be approved by Hang Seng,** subject to the Product Provider’s system records.

“Existing Customer”:

i. Apple Store Gift Card, value of HK\$700; or ii. Wellcome supermarket voucher, value of HK\$700; or iii. Trip.com Gift voucher, value of HK\$700; or iv. Polaroid Go Instant Camera, value of HK\$999; or vi. Marshall Willen Portable Bluetooth speaker, value of HK\$999

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.

d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers' internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.
