# MoneyHero x 富邦「卡數清」私人貸款條款及細則 -2025-01提取貸款優惠(「推廣」)

1.客戶凡在推廣期內通過MoneyHero指定優惠碼成功申請指定貸款並完成以下要求的合資格客戶,將獲得推廣獎賞(定義見下文)。

# Terms and Conditions of MoneyHero x Fubon Balance Transfer Personal Loan – 2025-01 Drawdown offer (the "**Promotion**")

1. Eligible Customers who successfully apply for a Designated Loan through MoneyHero designated promotion code during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

### 2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2025/1/3 6pm to 2025/1/24 6pm, dates inclusive (the "**Promotion Period**").

# 3. For the purposes of this Promotion:
