

(2024/09/30 6pm) MoneyHero x 安信銀聯卡

1. 合資格客戶

成功通過MoneyHero申請指定信用卡並完成本條款及細則所載的其他要求的合資格客戶將獲得推廣獎賞(定義如下)。

2. 推廣期

除非另有說明, 推廣期為2024/09/30 6pm至 2024/10/31 6pm(包括首尾兩天) (“推廣期”)。

3. 推廣活動相關定義

- a. “指定信用卡”指 安信EarnMORE銀聯鑽石卡及安信WeWa銀聯鑽石卡。
- b. “信用卡提供者”指安信信貸。
- c. “新客戶”指並未持有安信信用卡或遞交指定信用卡申請時過去6個月內未曾持有或取消任何安信信用卡之申請人。
- d. “現有客戶”指現在及 / 或緊接申請日期前6個月內曾持有任何安信信用卡之申請人。

4. 合資格客戶條件

為獲得推廣獎賞並成為“合資格客戶”, 客戶需:

- a. 為年滿 18 歲且持有有效香港身份證並在香港有通訊地址的新客戶;
- b. 在被重定向到信用卡提供者網站前向 MoneyHero 提供有效的電子郵件地址;
- c. 在推廣期內通過 MoneyHero 使用指定鏈接完成並提交指定信用卡的申請;
- d. 在收到 MoneyHero 獎賞換領表格後 7 天內完整填寫並提交 MoneyHero 獎賞換領表格;

5. 推廣獎賞及兌換

1. Eligible Customers who successfully apply for a Designated Card through MoneyHero during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

Unless otherwise specified, the promotion period of the Promotion is from 2024/09/30 6pm to 2024/10/31 6pm, dates inclusive (the “**Promotion Period**”).

3. For the purposes of this Promotion:

a. “Designated Card” means the PrimeCredit EarnMORE UnionPay Diamond Card or PrimeCredit WeWa UnionPay Diamond Card.

b. “Product Provider” means Prime Credit

c. “New Customer” means applicants who does not currently hold or have not held/canceled any card cards issued by PrimeCredit Limited in the past 6 months prior to the date of such application for a Designated Credit Card.

d. “Existing Customer” means applicants who are currently holding and/or have ever held any card cards issued by PrimeCredit Limited during the 6 months immediately preceding the date of application.

3. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;

c. Fully complete and submit an application for a Designated Card through MoneyHero using the designated link during the Promotion Period;

d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after receiving the MoneyHero Reward Redemption Form from MoneyHero; and

e. Have their application for the Designated Card approved by the Product Provider on or before 2024/11/30, subject to the Product Provider’s system records.

4. Promotion Rewards and Redemption

i. Apple Store Gift Card, value of HK\$200 (Not able to enjoy PrimeCredit Welcome Offer); or ii. Wellcome Shopping Voucher, value of HK\$200 (Not able to enjoy PrimeCredit Welcome Offer)

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.

d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers' internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.

e. If the application for the Designated Card is not made via the designated link, or an ad-blocker, tracking blocker or incognito mode is enabled during the application process, it may not be counted as valid and may lead to the user not being eligible for any Promotion Reward.
