

(2025/01/03 18:00 - 2025/02/03 18:00) MoneyHero x Zero Finance -提取貸款優惠 Drawdown Reward

1. 新客戶凡在推廣期內通過MoneyHero指定優惠碼成功申請指定貸款並完成以下要求的合資格客戶，將獲得推廣獎賞(定義見下文)。

2. 推廣期間

除非另有說明，推廣期間為2025/01/03 18:00至 2025/02/03 18:00(「推廣期間」)。

3. 推廣條款

a. 「指定貸款」指 X 現金A.I.貸款 及 X 大額私人貸款 (適合稅季)。

b. 「產品提供者」指Zero Finance。

c. 「新客戶」指於申請日期起計前 12 個月內於本公司 (Zero Finance Hong Kong Limited 和X8 Finance) 並未持有任何形式之貸款交易。

d. X現金A.I.貸款「指定優惠碼」指MH2700。

e. X 大額私人貸款 (適合稅季)「指定優惠碼」指MHPL。

g. X 結餘轉戶貸款「指定優惠碼」指MHDC。

4. 合資格客戶

為了獲得推廣獎賞並成為「合資格客戶」，客戶需：

- 為18歲或以上，持有有效香港身份證且在香港有通訊地址的新客戶；
- 在被重定向到產品提供者的網站之前向MoneyHero提供有效的電郵地址；

b. “**Product Provider**” means Zero Finance.

c. “**New Customer**” means a person who has not held any loan transaction of any kind with the Company (Zero Finance Hong Kong Limited and X8 Finance) within the 12 months preceding the date of application.

d. “**Designated Promo Code**” for X Cash.AI means “MH2700”.

e. “**Designated Promo Code**” for X Large Personal Loan (Suitable for tax loan) means “MHPL”.

g. “**Designated Promo Code**” for X Debt Consolidation Loan means “MHDC”.

4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;

c. Fully complete and submit an application for a Designated Loan through MoneyHero using the Designated Promo Code during the Promotion Period;

d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after receiving the MoneyHero Reward Redemption Form from MoneyHero;

e. Have their application for the Designated Loan approved by the Product Provider and complete drawdown for the Designated Loan].
