

(2025/1/1 12pm) MoneyHero x DBS Black World Mastercard & DBS Eminent Visa Signature Card & DBS Eminent Visa Platinum Card

### 1. 合資格客戶

成功通過MoneyHero申請指定信用卡並完成本條款及細則所載的其他要求的合資格客戶將獲得推廣獎賞(定義如下)。

### 2. 推廣期

除非另有說明, 推廣期為2025/1/1 12pm至 2025/2/3 12pm(包括首尾兩天) (“推廣期”)。

### 3. 推廣活動相關定義

- a. “指定信用卡”指 星展銀行Black World Mastercard 或 星展銀行Eminent Visa Signature Card 或 星展銀行 Eminent Visa Platinum Card。
- b. “信用卡提供者”指星展銀行。
- c. “新客戶”指在申請指定信用卡前 12 個月內未持有任何星展銀行信用卡的客戶。

### 4. 合資格客戶條件

為獲得推廣獎賞並成為“合資格客戶”, 客戶需:

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;

c. Fully complete and submit an application for a Designated Card through MoneyHero using the designated link during the Promotion Period;

d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after receiving the MoneyHero Reward Redemption Form from MoneyHero; and

e. Have their application for the Designated Card approved by the Product Provider on or before 2025/3/3, subject to the Product Provider’s system records.

Furusachi Ultimate Travel Line Front-opening Suitcase 31" (Random color) , value of HK\$4,300; or vi. Marshall Emberton II Bluetooth Speaker (Random color) , value of 1,499; or vii. PHILIPS ADD4911 Water Dispenser (Random color) , value of HK\$898.

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.
