

MoneyHero x OSL HK 條款及細則 (以下稱「推廣活動」) (202504)

1. 於推廣期內，透過MoneyHero申請指定帳戶，並獲批准且完成此處列明的其他要求的合資格客戶，將獲得推廣獎賞(各自定義如下)。

2. 推廣期

除非另有說明，推廣活動的推廣期為 2025/05/07 12pm 至 2025/05/13 6pm, 包括首尾兩日(以下稱「推廣期」)。

3. 本推廣活動而言：

- a. 「指定帳戶」是指OSL戶口。
- b. 「產品供應商」是指OSL證券。
- c. 「新客戶」是指於推廣活動的推廣期首次成功開立OSL證券帳戶的用戶。

4. 合資格客戶

為獲得推廣獎賞並成為「合資格客戶」，客戶需：

- a. 成為年滿18歲或以上，持有有效香港身份證並擁有香港通訊地址的新客戶；
- b. 在被重定向至產品供應商網站之前，向MoneyHero提供有效的電郵地址；

Terms and Conditions of MoneyHero x OSL HK (the “Promotion”) (202504)

1. Eligible Customers who apply for a Designated Account through MoneyHero during the Promotion Period, are approved for the same and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2025/05/07 12pm to 2025/05/13 6pm, dates inclusive (the “**Promotion Period**”).

3. For the purposes of this Promotion:

a. “**Designated Account**” means the OSL Securities Account.

b. “**Product Provider**” means OSL.

c. “**New Customer**” means Customers who have not opened a OSL Securities Account prior to their application for a Designated Securities Account as part of this Promotion.

4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;

c. Fully complete and submit an application for a Designated Account through MoneyHero using the designated link during the Promotion Period;

d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after receiving the MoneyHero Reward Redemption Form from MoneyHero (and in any event no later than 2025/05/20), including providing their email address in the “Application Reference Number” section of the MoneyHero Reward Redemption Form;

e. Have their application for the Designated Account approved by the Product Provider and complete the account opening procedure on or before 2025/05/13 6pm, according to the Product Provider’s system records.
