

MoneyHero x 信銀國際私人貸款條款及細則 – 2025-01提取貸款優惠(「推廣」)

1. 客戶凡在推廣期內通過MoneyHero成功申請指定貸款並完成以下要求的合資格客戶，將獲得推廣獎賞(定義見下文)。

2. 推廣期間

除非另有說明，推廣期間為2025/01/03 6pm至2025/02/03 12pm(「推廣期間」)。

3. 推廣條款

a. 「指定貸款」指信銀國際 \$smart Plus 分期貸款 (稅季優惠)及信銀國際 \$smart Plus 分期貸款 - 結餘轉戶。

b. 「產品提供者」指信銀國際。

4. 合資格客戶

為了獲得推廣獎賞並成為「合資格客戶」，客戶需：

- a. 為18歲或以上，持有有效香港身份證且在香港有通訊地址的客戶；
- b. 在被重新定向到產品提供者的網站之前向MoneyHero提供有效的電郵地址；

iv. 貸款額自 HK\$100,000 至 HK\$299,999 + 還款期 12 個月或以上：HK\$1,000 Apple Store 禮品卡 或 HK\$1,000 惠康現金券。

b. 合資格客戶將最多可獲得1個推廣獎賞。

c. 在確認資格後，兌換詳情將通過電子郵件發送至合資格客戶提供給MoneyHero的電郵地址。提供錯誤或不正確信息(由MoneyHero絕對酌情決定)的合資格客戶將無法收到任何推廣獎賞。

Terms and Conditions of MoneyHero x China CITIC Bank International Personal Loan – 2025-01 Drawdown offer (the “Promotion”)

1. Eligible Customers who successfully apply for a Designated Loan through MoneyHero during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2025/01/03 6pm to 2025/02/03 12pm, dates inclusive (the “Promotion Period”).

3. For the purposes of this Promotion:

a. “Designated Loan” means the CNCBI \$mart Plus Personal Installment Loan (Tax Season Offer); and China CITIC Bank International \$mart Plus Personal Installment Loan – Debt Consolidation

b. “Product Provider” means China CITIC Bank International .

4. Eligible Customers

In order to receive a Promotion Reward and to comprise “Eligible Customers”, customers are required to:

a. Be a Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;

c. Fully complete and submit an application for a Designated Loan through MoneyHero using the designated link during the Promotion Period, with loan tenor of 12 months or above;

d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after receiving the MoneyHero Reward Redemption Form from MoneyHero;

e. Have their application for the Designated Loan approved by the Product Provider and complete drawdown for the Designated Loan within 1 month;

5. Promotion Rewards and Redemption

iv. Loan amount HK\$100,000 – HK\$299,999 + repayment period 12 months or more : HK\$1,000 Wellcome voucher or HK\$1,000 apple store gift card

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.

d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers' internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.

e.
