

(2025/03/31 6pm) MoneyHero x HSBC - HSBC Red Credit Card

1. 成功通過 MoneyHero 申請指定信用卡並完成以下要求的合資格指定信用卡客戶將獲得以下推廣獎賞(各自定義如下)。

2. 推廣期

除非另有說明, 推廣活動的推廣期為 2025/03/31 6pm 至 2025/04/30 6pm(包括首尾兩日)(「推廣期」)。

3. 推廣活動定義

a. 「指定信用卡」是指由香港上海滙豐銀行有限公司(及其繼承人及受讓人)於香港發出的滙豐Red信用卡。
