# MoneyHero x LongBridge 條款及細則 - (以下稱「推廣活動」)(202503)

1. 於推廣期內, 透過MoneyHero申請指定帳戶, 並獲批准且完成此處列明的其他要求的合資格客戶, 將獲得推廣獎賞(各自定義如下)。
