

MoneyHero x StashAway 證券 HK 條款及細則 (以下稱「推廣活動」) (202503)

1. 於推廣期內, 透過MoneyHero申請指定帳戶, 並獲批准且完成此處列明的其他要求的合資格客戶, 將獲得推廣獎賞(各自定義如下)。

2. 推廣期

除非另有說明, 推廣活動的推廣期為2025/02/28 6pm至2025/03/31 6pm, 包括首尾兩日(以下稱「推廣期」)。

3. 本推廣活動而言:

- a. 「指定帳戶」是指StashAway證券戶口。
- b. 「產品供應商」是指StashAway證券。
- c. 「新客戶」是指於推廣活動的推廣期首次成功開立StashAway證券賬戶的用戶。

4. 合資格客戶

b. 合資格客戶將最多獲得1個推廣獎賞。

c. 為免產生疑問, 成為「合資格客戶」只需向指定帳戶注入指定金額, 無需訂閱或購買任何證券、投資產品及/或進行任何證券或投資產品的交易或交易。

Terms and Conditions of MoneyHero x StashAway HK (the “Promotion”) (202503)

1. Eligible Customers who apply for a Designated Account through MoneyHero during the Promotion Period, are approved for the same and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2025/02/28 6pm to 2025/03/31 6pm, dates inclusive (the “Promotion Period”).

3. For the purposes of this Promotion:

a. “Designated Account” means the StashAway Securities Account.

b. “Product Provider” means StashAway.

c. “New Customer” means Customers who have not opened a StashAway Securities Account prior to their application for a Designated Securities Account as part of this Promotion.

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

c.
