

【稅季大派HK\$10,000現金券】(“推廣活動”)條款及細則

1. MoneyHero Global Limited (“MoneyHero”)是本次推廣活動的主辦方。根據這此推廣條款和條件，符合條件的參加者(“合資格參加者”)通過MoneyHero網站成功申請合資格金融產品後獲得產品提供者批核，並於指定獎賞換領表格回答指定問題，有機會獲得以下比實獎品(如以下所定義)。

2. 推廣活動期間

3. 參加資格

6. 活動規則 (比賽)

- i. 為參加是次比賽，合資格參賽者必須提交 MoneyHero 獎賞換領表格中比賽問題的答案。比賽是一場技巧遊戲，而不是機會或運氣。

2. Promotion Period

6. Conduct of Contest

- i. In order to participate in the Contest, Eligible Participants must submit answers to the Contest Question[s] in the MoneyHero Reward Redemption Form. The Contest is a game of skill and not chance or luck.
- ii. Answers to the Contest Question must be in Chinese and not exceed 100 characters.
- iii. The MoneyHero judging panel will review the submissions and select the one hundred (100) most creative answers submitted by Eligible Participants as the Contest winners ("**Winners**").
