

# MoneyHero x 富途證券 HK 條款及細則 (以下稱「推廣活動」) (202503)

1. 於推廣期內, 透過MoneyHero申請指定帳戶, 並獲批准且完成此處列明的其他要求的合資格客戶, 將獲得推廣獎賞(各自定義如下)。

## 2. 推廣期

除非另有說明, 推廣活動的推廣期為2025/02/28 6pm 至 2025/03/31 6pm, 包括首尾兩日(以下稱「推廣期」)。

## 3. 本推廣活動而言:

- a. 「指定帳戶」是指富途證券戶口。
- b. 「產品供應商」是指富途證券。
- c. 「新客戶」是指於推廣活動的推廣期首次成功開立富途證券賬戶的用戶。
- d. 「指定優惠碼」是指「MHFUTU」。

## 4. 合資格客戶

為獲得推廣獎賞並成為「合資格客戶」, 客戶需:

- b. 在被重定向至產品供應商網站之前, 向MoneyHero提供有效的電郵地址;

## 5. 推廣獎賞及兌換

- b. 合資格客戶將最多獲得1個推廣獎賞。

# Terms and Conditions of MoneyHero x Futu HK (the “Promotion”) (202503)

1. Eligible Customers who apply for a Designated Account through MoneyHero during the Promotion Period, are approved for the same and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

## 2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2025/02/28 6pm to 2025/03/31 6pm, dates inclusive (the “Promotion Period”).

## 3. For the purposes of this Promotion:

a. “Designated Account” means the Futu Securities Account.

b. “Product Provider” means Futu.

c. “New Customer” means Customers who have not opened a Futu Securities Account prior to their application for a Designated Securities Account as part of this Promotion.

## 4. Eligible Customers

In order to receive a Promotion Reward and to comprise “Eligible Customers”, customers are required to:

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;

c. Fully complete and submit an application for a Designated Account through MoneyHero using the designated link during the Promotion Period;

d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after receiving the MoneyHero Reward Redemption Form from MoneyHero (and in any event no later than 2025/04/07), including providing their Futu Account ID (8 digits) in the “Application Reference Number” section of the MoneyHero Reward Redemption Form;

e. Have their application for the Designated Account approved by the Product Provider and complete the account opening procedure on or before 2025/03/31 6pm, according to the Product Provider’s system records; and

- Bowers & Wilkins PX7 S2e Over-Ear Wireless Noise Cancelling Headphones (value of HK\$3,380; Random Color) ; OR
- Apple Store Gift Card (value of HK\$2,000) ; OR
- Wellcome Shopping Voucher (value of HK\$2,000) ; OR
- Trip.com e-Voucher (value of HK\$2,000) ; OR
- Futu Cash Voucher (value of HK\$2,000).

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

c. For the avoidance of doubt, in order to comprise “Eligible Customers”, a user is only required to fund the Designated Account with the specified amount and is not required to subscribe to or purchase any securities, investment products and/or initiate any transactions or dealings of securities or investment products.
