

MoneyHero 尊貴客戶特選禮遇 – 20 萬港元免費個人意外保障(一年保障期)(「優惠」) MoneyHero exclusive customer reward – free HKD 200,000 Personal Accident Protection (one-year cover) ("Offer")

## 優惠條款及細則

## Offer terms and conditions

- 1. 此優惠之推廣期為即日起至 2025 年 12 月 31 日爲止(包括首尾兩天)(「推廣期」)。 This Offer is valid from now till December 31, 2025 (both dates inclusive) ("Promotion Period").
- 2. 此優惠只適用於 MoneyHero 特選客戶,並需於推廣期間成功透過蘇黎世人壽保險(香港)有限公司(「蘇黎世人壽」) 之指定平台完成登記,方可免費獲發個人意外保障一份,最高保障金額為 20 萬港元,保障期為一年(「此保障」)。 This Offer is only applicable to selected MoneyHero customers who successfully complete the registration through the designated platform of Zurich Life Insurance (Hong Kong) Limited ("Zurich Life") during the Promotion Period. Zurich Life reserves the right of final decision with respect to the eligibility of MoneyHero customers to receive this Protection.
- 4. 每位合資格的客戶只可獲得由蘇黎世人壽於 MoneyHero 平台上提供的免費獎賞一次。如客戶曾經登記過其他由蘇黎世人壽提供予 MoneyHero 客戶的免費獎賞‧則有關客戶不能再登記此免費個人意外保障。
  Each Eligible Customer can only register for the free reward offered by Zurich Life on the MoneyHero platform once.
