# (2025/05/29 6pm) MoneyHero x Standard Chartered Smart Credit Card

1. 成功通過 MoneyHero 申請指定信用卡並完成以下要求的合資格客戶將獲得推廣獎賞(各自定義如下)。

# 2. 推廣期
