

(2024/12/2 6pm) MoneyHero x Citi_Other Card

1. 合資格客戶

成功通過MoneyHero申請指定信用卡並完成本條款及細則所載的其他要求的合資格客戶將獲得推廣獎賞(定義如下)。

2. 推廣期

除非另有說明, 推廣期為2024/12/2 6pm至 2024/12/9 6pm(包括首尾兩天) (“推廣期”)。

3. 推廣活動相關定義

- a. “指定信用卡”指Citi Cash Back 信用卡或Citi Rewards 銀聯信用卡或Citi PremierMiles 信用卡或Citi Rewards 信用卡。
- b. “信用卡提供者”指花旗銀行。
- c. “新客戶”指在申請指定信用卡前 12 個月內未持有花旗銀行任何信用卡的客戶。
- d. “合資格簽賬”指HKD\$4000。

4. 合資格客戶條件

b. 合資格客戶最多可獲得 1 項推廣獎賞。

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero.
