- 1. The promotion period is valid from March 1, 2025 to May 31, 2025, both dates inclusive ("Promotion Period").
- 2. This promotion applies to Citi PremierMiles Cardholders ("Eligible Cardholders") of Citi Credit Card ("Designated Credit Card") issued by Citibank (Hong Kong) Limited ("Citibank") listed at the promotional email/SMS/Push notification for this promotion. Transactions made by the Eligible Cardholders (including Eligible principal and supplementary card(s)) will be combined.
