(2025/03/27 6pm) MoneyHero x CNCBI - 信銀國際大灣區雙幣信用卡 / 信銀國際Motion信用卡

1. 成功通過 MoneyHero 申請指定信用卡並完成以下要求的合資格客戶將獲得推廣獎賞(各自定義如下)。
