

## (2024/09/30 6pm) MoneyHero x Sim Credit Card

1. 成功通過 MoneyHero 申請指定信用卡並完成以下要求的合資格客戶將獲得推廣獎賞(各自定義如下)。

### 2. 推廣期

除非另有說明, 推廣活動的推廣期為 2024/09/30 6pm至2024/10/31 6pm(包括首尾兩日)(「推廣期」)。

### 3. 推廣活動定義

### 4. 合資格客戶

為獲得推廣獎賞並成為「合資格客戶」, 客戶需:

c. “**New Customer**” means customers who do not currently hold and have not cancelled any principal card of United Asia Finance Limited Credit Card in the 12 months prior to the date of approval of their current application for a Designated Card as part of this Promotion or at the time of the application, not currently using any service (including but not limited to any loan or credit services or maintaining any with Card Issuer and has not, within the past 24 calendar months from the month of application, used any service (including but not limited to any loan or credit services) of Card Issuer or maintained any account (including but not limited to any loan accounts) with Card Issuer. ## 4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;

c. Fully complete and submit an application for a Designated Card through MoneyHero using the designated link during the Promotion Period;

d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after receiving the MoneyHero Reward Redemption Form from MoneyHero;

e. Have their application for the Designated Card approved by the Product Provider on or before 2024/11/30, subject to the Product Provider’s system records; and

c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero within 90 days. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.

d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers’ internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.
