

(2025/07/31 6pm) MoneyHero x DBS Black World Mastercard & DBS Eminent Visa Signature Card & DBS Eminent Visa Platinum Card

1.合資格客戶

成功通過MoneyHero申請指定信用卡並完成本條款及細則所載的其他要求的合資格客戶將獲得推廣獎賞（定義如下）。

2.推廣期

除非另有說明，推廣期為 2025/07/31 6pm 至 2025/09/01 6pm（包括首尾兩天）（“推廣期”）。

3.推廣活動相關定義

a.“指定信用卡”指 星展銀行Black World Mastercard 或 星展銀行Eminent Visa Signature Card 或 星展銀行Eminent Visa Platinum Card。

b.“信用卡提供者”指 星展銀行。

c.“新客戶”指在 申請指定信用卡前 12 個月內未持有任何星展銀行信用卡的客戶。

4.合資格客戶條件

c. “**New Customer**” means customers who have not held any credit card with DBS Bank in the 12 months preceding the date on which their application for a Designated Card is made as part of this Promotion.

4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

- a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;
- b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;
- c. Fully complete and submit an application for a Designated Card through MoneyHero using the designated link during the Promotion Period;
