# MoneyHero x LongBridge 條款及細則 - (以下稱「推廣活動」) (202505)

p. These Terms and Conditions shall be governed by and construed in accordance with the laws of Hong Kong.

q. In the event of any discrepancies between the English and Chinese versions of these Terms and Conditions, the English version shall prevail.
