# MoneyHero x UA亞洲聯合財務(UA) 私人貸款條款及細則 – 202505申請獎勵(無須提取貸款) (「推廣活動」)

- h. 申請人必須留下有效聯繫資訊. 並須由 UA 客戶服務人員成功聯繫. 方可合資格。

1. Customers who successfully apply for a United Asia Finance (UA) Personal Loan (a "Designated Loan") via MoneyHero, have their application for a Designated Loan confirmed by United Asia Finance (UA), leave valid contact information and must be contacted by UA Customer Service Officer successfully, and submit the MoneyHero Reward Redemption Form within the specified period will receive a Promotion Reward.

- h. Leave valid contact information and must be contacted by UA Customer Service Officer successfully.
- Eligibility for rewards is restricted to applications with loan results of "Disbursed" or "Rejected."

### 5. Promotion Rewards and Redemption
